Property Tax Penalty Cancellations – The San Diego County Treasurer-Tax Collector's Office is now accepting penalty cancellation requests for those who have been directly impacted by the coronavirus pandemic. If you were unable to make your property tax payment on time due to COVID-19, complete and return the special penalty cancellation request form. Requests must be submitted by **June 30**.

Limited Reopening of Businesses – San Diego is ready to safely reopen as soon as state orders are lifted, with <u>guidelines for businesses</u> to protect employees, customers and the public.
