Anna McPherson stated that this last Tuesday City Council heard the appeal of the Historic Designation of the Frederick Thomas House located at 540 Thorn Street, HRB #1381. Members of the Council voted to deny the appeal and uphold the historic designation.

Anna McPherson also announced that the appeal of the Florence Hotel Carriage House located at 2004 4<sup>th</sup> Avenue and the Helen Bradish Spec House #1 located at 328 Grape Street will be heard on May 18<sup>th</sup>. A FAIRER PROCESS COULD BE ACHIEVED BY: (1) HAVING TWO REPORTS, ONE PRO, ONE CON; OR (2) FOLLOW THE HISTORIC REVIEW PROCESS OF THE CITY OF CORONADO, WHERE EACH PROPERTY IS ASSIGNED ARIBITRARILY TO AN INDEPENDENT CONSULTANT WITHOUT PRECONCEPTIONS OR TIES TO THE OWNER. (THERE IS A SET FEE FOR CONSULTANTS.).
- 2. BOARDMEMBERS THE DEPARTMENT IS UNDERSTAFFED AND NEED MORE PERSONNEL.
- 3. BOARDMEMBERS A PAY RAISE FOR THE STAFF WHO DO AN EXCELLENT JOB OF KEEPING THE BOARD INFORMED AND PROCESS A VAST AMOUNT OF INFORMATION TO HELP THE BOARD SERVE THE CITY OF SAN DIEGO BETTER.
- 4. BOARDMEMBERS TO FILL CURRENT VACANCY THAT HAS BEEN VACANT FOR OVER ONE YEAR.
- 5. BOARDMEMBERS TO ENCOURAGE THE CITY COUNCIL TO ADD DIVERSITY TO THE HISTORICAL RESOURCES BOARD WHEN FILLING BOARD SEATS.
