This letter will serve as OHLA's plan for the month of April 2022 to achieve the Skilled and Trained Work Force requirements for the Morena Conveyance North Project.

OHLA will ensure the crews will have the required number of Apprentice Graduate Journeymen to meet the requirements. OHLA has met the minimum requirement for the Laborers on site however, not for the Operators. OHLA will ensure to dispatch Operators who are an Apprentice Graduate in order to achieve the Skilled and Trained Work Force plan.

As field work increases and the number of crews on site increase, in addition to bringing on Apprentice Graduates, OHL will begin the process of enrolling any laborers and operators that meet the minimum requirements of years of journeyman experience into the apprenticeship classes in order to complete their certification.
