Co-chairs welcomed partners, reviewed the agenda, and led a culture share activity.

Partner Announcements

- Office of Juan Vargas 51st Congressional District announced that it is accepting applications for its Congressional Art Competition. The submission deadline is April 28th.
- California Coast Credit Union announced the launch of the Financial Wellness Center located in **Logan Heights CDC** on May 10th from 4:00 –6:00 pm.
- Central San Diego Black Chamber of Commerce announced its Digital Literacy Course in basic computer skills for small business owners. Attendees will be provided a free computer which they can keep after the course.
- Accessity announced that it has been awarded \$5.9M from the federal CDFI Equity Recovery Program to help promote and improve small businesses in San Diego.
- **Live Well San Diego** shared their Business Sector Newsletter <u>sign-up</u> to gain access to County announcements, and resources. Community organizations are encouraged to submit content to be featured on the newsletter.
- Jacobs Center for Neighborhood Innovation announced its upcoming equipment trainings for creating podcasts and video content in May.
- Office of Juan Vargas 51st Congressional District announced that the House Financial Services Committee convened to increase access to capital.

Launching of Financial Wellness Center with California Coast Credit Union at Logan Heights CDC

- California Coast Credit Union shared updates on the launch of its Financial Wellness Center located in Logan Heights CDC. The grand opening will be on Wednesday, May 10th from 4 to 6pm.
- The Financial Wellness Center will be open to the community for drop-in, no-cost visits to provide financial education and services in order to continue advancing financial literacy.
- A personal desktop computer will be available for attendees to assess their financial literacy via the *Enrich Online Program*, available both in English and Spanish.

<u>Planning for Promise Zone Business Walk in June</u>

- The Promise Zone—in collaboration with The Economic Development Department's (EDD) Business Expansion, Attraction and Retention (BEAR) team—would like to plan and host a Business Walk in June. This would be led by Promise Zone staff with the support of this working group.
- Previous Business Walks have been successful because we've partnered with trusted organizations to make the contact through targeted outreach and provide feedback on potential corridors to target.
- The purpose of this Business Walk to show that the Promise Zone partner network is interested in learning about 1) the issues affecting them and 2) the ways we can support them.
- Staff have narrowed down three potential corridors:
 - o Imperial Ave (19th through 32nd/L St)
 - o Black Arts and Culture District (Imperial Ave 61st to 69th)
 - National Ave (National Ave through Boston Ave)

<u>City of San Diego FY24 Budget Update / Monica Hardman, City of San Diego – EDD</u> *Monica Hardman, Economic Development Department — City of San Diego*

- Co-chairs introduced Monica Hardman of the Economic Development Department to provide an update of the City's Fiscal Year 2024 Budget. This presentation highlighted budgetary items and goals which focus on addressing homelessness, business improvement capacity, and infrastructure in tandem with EDD's budgetary goals for FY24. Partnerships and collaboration were highlighted as other opportunities to bring-in funding.
- On Friday, April 14, 2023 the Mayor released the Fiscal Year 2024 Proposed Budget.
 From May 3rd to 9th, City Departments will present their budget at the Budget Review Committee.
- On May 16, 2023, the Mayor will recommend revisions to the Fiscal Year 2024 Proposed Budget (May Revision), which will be presented to the Budget Review Committee on May 18, 2023. See the figure below for more key dates.
