#### Grant Opportunities

- <u>Community Projects, Programs & Services (CPPS) Funding Program</u>: The City Council offices are awarding nonprofit organizations and public agencies for one-time community, social, environmental, cultural, and recreational needs that serve lawful public purposes.
  - **Application Deadline:** May 31<sup>st</sup>, 2023
- <u>Outdoor Business Grant</u>: The City of San Diego's Economic Development Department (EDD) will be providing grants up to \$20,000 to eligible businesses following the Spaces as Places program guidelines for expanding business operations outdoors into the public right-of-way.
  - **Application Deadline:** June 30<sup>th</sup>, 2023

- <u>San Diego (SD) Food Justice Project Summer 2023 Cohort 4</u>: The SD Food Justice Project will support entrepreneurs such as micro-enterprise home kitchen operations (MEKHOS), sidewalk vendors, pop-ups and caterers, and immigrant-owned restaurants through the G.E.T. Cooking Training Program (Grant for Entrepreneurship Training and Home Cooking Program).

#### Promise Zone Business Walk Update

SDPZ Staff

- Promise Zone staff and the Economic Development Department (EDD) are coordinating a Business Walk in Council District 8 in June.
- The Business Walk has a two-pronged approach: (1) Provide information on the available resources for businesses operating in the City, and (2) hear first-hand from business owners how the City can further support the business community.
- Staff conducted a Zoom poll and identified the following corridor as a priority for this Business Walk:
  - Imperial Ave & 19th 32nd (Sherman Heights/Logan Heights/Grant Hill)
- The two proposed dates and times that EDD has identified are:
  - Thursday, June 22<sup>nd</sup> / 2:00 5:00 PM (priority date)
  - Wednesday, June 28<sup>th</sup> / 2:00 5:00 PM (secondary date)



- Partners expressed interest in assessing tree coverage and needs during this Business Walk.
- A partner suggested sharing with business owners the City's plans for infrastructure repairs and improvements along Imperial Ave.

### Environmental Justice Element Update

Paola, Boylan, City of San Diego—Planning Department

- Co-chairs welcomed Paola Boylan, Senior Planner with the City of San Diego's Planning Department, to share resources for learning about the new Environmental Justice Element.
- The recently launched <u>Environmental Justice Element webpage</u> contains more background information such as data points the Department has been studying, the detailed outreach and engagement plan, as well as how to get involved and stay connected.
- The initiative has a small amount of funding for community-based organizations to help support with outreach and engagement. The Department has released evaluation criteria in order to select organizations.
- The City of San Diego will use the <u>Draft Evaluation Criteria</u> to look for a diverse mix of organizations to support outreach and engagement. The public is welcome and encouraged to review and provide feedback and comments on the proposed Evaluation Criteria by emailing <u>PublicSpaces@sandiego.gov.</u> The deadline for public input is Monday, May 22<sup>nd</sup>, 2023, at 8:00 AM.

#### Proposed Roundabouts Along Imperial Ave

- The County of San Diego's Health and Human Services Agency shared that it is working with Circulate San Diego (SD) and the City of San Diego on a five-year project funded by the Racial and Ethnic Approaches to Community Health (REACH) grant.
- This collaborative project will improve road safety and active transportation in Southeastern neighborhoods of San Diego, specifically along Imperial Ave in the Chollas View/Encanto neighborhood.
- Throughout the project, Circulate SD has been conducting community engagement, educating people on roundabouts and safer streets, and learning about residents' experiences and visions for future improvements.
- Circulate SD presented the preliminary sketches for multiple proposed roundabouts along Imperial Ave. See the slide below for one of the four proposed roundabouts.
- Partners expressed concern that the bike lanes are shown to be inside while the parking lanes are on the outside for three of the four proposed roundabouts. This is not safe for bicyclists and needs to be flipped.
- Partners also expressed the need for high visibility crosswalks with flashing lights as well as yellow arrow signs showing the direction of traffic.
- Partners emphasized the need for greenery and trees to be included in the plan.
