Partner Announcements

- **Congressman Vargas** who is the federal representative of the 52nd district noted that on Monday they hosted their <u>service academy night</u>, where high school students and counselors were able to learn more about the opportunities to join one of these academies. The participants included the U.S. Air Force Academy, U.S. Coast Guard Academy, U.S. Naval Academy, U.S. Merchant Marine Academy, and the U.S. Military Academy. This event was hosted at the SBC center in National City.
- **IRC SBDC** is reopening their Global Food Market on Saturday, and we will continue to host it once a month. The event is held every third Saturday of the month in City Heights at Fair 44 on El Cajon Boulevard. It is a collaborative effort with the El Cajon BLVD Business Improvement District and aims to provide a free space for our clients to showcase and sell their products outside their homes.
- Live Well Center The Live Well Center offers County services that are traumainformed and culturally sensitive to promote health and well-being of the residents and strengthen families and communities. Grant Update: Catholic Campaign for Human Development

- **Application deadline:** Pre-applications are due November 1, 2023.
- Grant amount: \$25,000 to \$75,000
- **Description:** The Catholic Campaign for Human Development (CCHD) is the domestic anti-poverty program of the U.S. Catholic Bishops. CCHD works to break the cycle of poverty by helping low-income people participate in decisions that affect their lives, families, and communities. CCHD's Community Development Grant Program supports organizations that are led by people living in poverty and work to address the root causes of poverty by nurturing solidarity between the poor and non-poor and facilitating the participation of people living in poverty in decisions that perpetuate poverty in their lives. The Economic Development Grant Program supports economic development initiatives that significantly include the voice of the poor and marginalized in developing new businesses that offer good jobs or develop assets that will be owned and enjoyed by local communities. (Applicant organizations must not promote activities that work against Catholic values.)

The City of San Diego is currently developing its 2025-2029 Consolidated Plan, a planning document required by the U.S. Department of Housing and Urban Development (HUD) to help guide the investment of funds from three federal funding streams: the Community Development Block Grant (CDBG) program, the HOME Investment Partnerships program (HOME), and the Emergency Solutions Grants program (ESG).
