Diamond Business Improvement District

Latrell Crenshaw, Sean Karafin, City of San Diego Economic Development Department **Takeaways from the Diamond BID Presentation:**

- Business Improvements Districts (BIDs) are geographic-based areas with laws in our municipal code which are allowed through state laws, and date back to 1970.
- There are 18 BIDs in the city, which means the tenants in that area voted and passed an assessment on themselves, which in turns offers various benefits to the business community.
- Adams Avenue is an example of a BID, run by a non-profit.
- Property and Business Improvement District is the largest BID.
- If your business is in a BID, then there's specific assessment on those dollars spent to administer program services.
- If the funds don't get used this year, they cannot be siphoned off for other purposes and they are rolled over to the next year.
- Currently there is no administrator of the contract.
- BIDs are determined through a Maintenance Assessment District (MAD) which goes to Council with authority to administer funds, and then an Advisory board selects non-profit and selects budgets.
- Businesses that pay towards the BID can then benefit from the BID processes.

Tactical Planning with Outcome/Metric Setting:

Breakout group 1: (Objective 1: Strengthen the Business Base and Attract New Businesses to Vacant Land)



- Create a master document of resources and benefits/services businesses are provided and how they can use those services.
- Reimagine the budget (What funding opportunities are available for the businesses?)
- The board oversees the activities (Business owners make sure budget/activities are in alignment with what is needed.)

Breakout group 2: (Objective 2: Make Infrastructure Improvements and Address Disparities)

- UCP does a lot of work with SANDAG. Barry represents a social equity working group at SANDAG where they discuss these things often.
- Discussed equity and that some areas need a MAD because canopies aren't prioritized. There's a tax for tree canopies! So, are there tree canopies with no MAD?
- Infrastructure should be aimed to improve climate resiliency.
- Any infrastructure improvements in the Promise Zone should consider climate change effects.
- SANDAG is making progress in their regional plan to shift resources to the Promise
 Zone and other under-resourced communities.
- The Church's Chicken lot on the corner of market and Euclid...what do residents want from that location? Is it still in the process of getting sold? Could that potentially be a place where we could put green a space on that spot?
- There's lot of activity in that area, must make use of this space to positively affect the community.
- Tree canopies:
 - City is requiring a MAD for tree canopies in the Promise Zone, this may be inequitable if MADs are not required where canopies already exist or in more affluent areas.
 - Residents can't afford to do that, which makes getting things done more difficult with more red tape.
 - Prioritize tree canopies as a part of green space.

Breakout room 3: (Objective 3: Support Small Businesses, Entrepreneurs, and Self-Employed Residents)

- Refer people to the Emerge Program if loan/ grants are something we can start with.
 A lot of the Promise Zone is covered, and that can bridge the gap with the capital and grant portion as well.
- Incentivize finding a way so that the people looking for resources are looking for the correct resources.



- Businesses should be provided a resource page for businesses when they sign up for their business certificate.
- We want to make sure our goals are obtainable.
