## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - 2023 ICF (International Christmas Festival) December Nights

**COMMUNITY PLAN AREA:** Balboa Park

**COUNCIL DISTRICT:** 3

**LOCATION:** The House of Pacific Relations International Cottages and Lawn, Balboa Park

PROJECT DESCRIPTION: Special Event Permit for the House of Pacific Relations International Christmas Festival that would take place on December 1-2, 2023. The event would include onsite food preparation, food and beverages, vendors, tables, chairs, tents, a generator, a stage, a fenced-in beer garden, entertainment, portable restrooms, trash/recycling containers, and alcohol. Noise associated with the event activities and set-up/dismantling would occur from 6 AM on November 30, 2023, until 5 PM December 3, 2023. Set-up would occur over three days starting at 6 AM until 6 PM on November 30, 2023, from 6 AM until 3 PM on December 1, 2023, and 6 AM until 11 AM on December 2, 2023. The event would occur from 3 PM until 11 PM on December 1, 2023, and from 11 AM until 11 PM on December 2, 2023. Dismantling would occur from 11 PM until 12 Midnight on December 2, 2023, and from 12 AM to 5 PM on December 3, 2023.

Road closures associated with the event would include the corner of Pan American Plaza and Pan American Road W to the corner of Pan American Plaza and Presidents Way on 12/1/23 from 5pm-11pm and 12:00pm-11:00pm on 12/2/23.

Parking would be closed within the following parking lots:

Palisades, Alcazar, Space Theater, Casa de Balboa, Pepper Grove, Federal, Gold Gulch, Organ Pavilion, and North Carousel parking lots will be permit only lots starting Friday 12/1/23 at 12AM through Sunday 12/3/23 at 12PM. Inspiration Point, Bea Evanson, and South Carousel lots will be managed through a ROE parking management company starting Friday 12/1/23 at 6AM through Saturday 12/2/23 at 11:59PM.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
