Sand management continues in several areas of Mission Bay shorelines. Upcoming events include Baja Bound, Mission BayFest and PIFA. No alcohol, road or parking lot closures. PA system for music and announcements only. The bike route will remain the same. No ebikes allowed on bayside walk and boardwalk

#### **INFORMATION ITEMS**

401. SeaWorld project, Lindsay Boyd, Project Manager, SeaWorld shared plans to construct a new 19,000 sq ft storage building in Area 3 which will not exceed 30 feet height limit. This building is included in SeaWorld's Master Plan

402. Overview of the ongoing Clairemont Complete Corridors study, Andrew Camacho, Associate Engineer, SANDAG and Andrew Prescott, Senior Transportation Planner, CR Associates presented a comprehensive overview of traffic studies and preliminary designs to identify multimodal enhancements along Morena Boulevard and Clairemont Drive with a focus of connections to/from the newly opened Blue Line Trolley Stations at Clairemont Drive, Tecolote Road and Mission Bay. The plans include safety measures and better access

Jeff Johnson commented that roundabouts will not accommodate the large RVs that travel these connectors, He would like to see a dedicated ped/bike bridge from Tolley Station to Mission Bay Park due to concerns about ped/bike safety. Giovanni and Judith would also like to see dedicated access to Mission Bay Park
