- 201. Update on \$790,000 grant money for the park: Update was given by Emily Piatanesi, Mayor Todd Gloria's Community Representative. The project's total cost is \$1,773,168.80. Funds have been obtained through AD-76, general funds CIP funding, old parks fund and RB DIF funds. Design is anticipated to be completed by September, 2025. Construction is anticipated to be from May, 2026 through December, 2026.Scope of work includes sports field lights on fields #2 and #4, sidewalk between fields #2 and #3, security lighting along the pathway, upgrade existing security lights to LED and additional security lights as needed.
