There was a comment about how there's not enough money towards the turf in the Canyonside budget, a question about the wood awning at the Hilltop Courtyard.

G. ACTION ITEMS

GDP Amendment – Expansion of the Tennis Facility and Addition/Relocation of Batting Cages

• Jeff Greenwald presents a continuation of the conceptual plan to add amenities to accommodate the demand for the approximately 380 people on the 3 year waitlist for the 12 tennis courts.

- There was a grant of \$2,553,857 for the expansion. Grant work must be done by March 1st, 2026.
- The conceptual plan was presented to CRG as an information item on January 26th, 2023. The conceptual plan was approved 6-0-0 by CRG as an Action item on March 22nd, 2023. The CRG considered a GDP amendment on July 27th, 2023, though the action item was tabled so that they could find a new spot to relocate the batting cage for Cricket. The current plan is to complete geotechnical and civil engineering studies and incorporate the results into a GDP amendment to the Parks and Rec Board, get Parks and Rec Board's approval by late 2023, and start the project by January 2024.
- Since the last meeting they have found a new area for the batting cage since the area they previously planned was a flood zone. The new area is by field 1.
- There are concerns about waterways and avoiding sensitive habitats.
- The geotechnical and civil engineering studies will answer questions such as soil conditions at the construction areas. Required retaining wall and soil treatments, biological impacts and mitigations, surveying and staking to ensure appropriate fit, location and appropriate access to water and sewer lines. Based on these results, architectural and traffic engineer guidance, more specifics will be provided to parks and rec staff before the presentation to the Parks and Rec board.
- Action item was approved 8-0-0.
