#### **COMMITTEE RECOMMENDATION**

The Policy & Funding Committee will make a recommendation on the tentative awards for the Impact Pilot. at the committee meeting scheduled for December 15, 2023 before the full City of San Diego Commission for Arts and Culture (Commission) meeting.

Staff recommendation submitted to the Policy & Funding Committee follows: Recommend to the Commission the following ten applicants for Impact Pilot awards, as submitted by the advisory panel: All for Logan, Asian Story Theatre, Kim Phillips, Little Saigon San Diego, San Diego Made, South Bay Alliance Association, The Aja Project, The Urban Collaborative, Tu y Yo Theater, and WorldBeat Cultural Center.

### BACKGROUND

The City of San Diego's (City) Impact funding category supports excellence, innovation and creativity within the San Diego arts, cultural and creative sectors through targeted City funding initiatives in alignment with the City's arts and cultural strategies and priorities. Depending on the initiatives within the Impact category, eligible applicants may include tax-exempt nonprofit organizations and artists.

The City issued the guidelines for the Impact funding category pilot on October 9, 2023. In this inaugural Impact cycle, the City acknowledged post-pandemic challenges to the arts and culture cultural ecosystems and historical imbalances in access to funding as well as the need to acknowledge, encourage and preserve the cultural heritage of all San Diegans. This inaugural cycle of the Impact category which focuses on transforming the future of San Diego through new models for creative change-making in and through the arts, responds to the City of San Diego's adopted Strategic Plan and its Goal to Protect and Enrich Every Neighborhood, and the City's equity commitment to bring resources to every neighborhood, recognizing the historical underinvestment in some areas of the city.

The competitive process was open to artists, nonprofit organizations and organizations conducting notfor-profit work lacking formal nonprofit status with a nonprofit fiscal sponsor to submit an application for a project that would take place in the San Diego Promise Zone or Communities of Concern and in response to one of the following focus areas: Arts and Heritage, Arts and Sustainability and Arts and a Just City. Each application required a designated lead applicant that may have been an artist or organization as well as a primary collaborating partner. Lead organization applicants were permitted to collaborate on an application with an artist or organization. Lead artist applicants were required to collaborate with an organization. The lead applicant, whether an artist or organization, was required to be located within the San Diego Promise Zone or San Diego Communities of Concern that had been designated with a categorization of having very low, low or moderate access to opportunity as specified in the 2021 City of San Diego Climate Equity Index. Both the lead applicant and the collaborating partner, whether an artist or organizations, were required to have annual budgets under \$500,000. The Impact Pilot provides up to 10 collaborative partnerships with \$100,000 in funding for an 18-month activity period that is divided into two phases, one for project planning and development and one for project implementation and a benefit from City organized networking and capacity building opportunities. The first phase will take place from January through June 2024 to further develop their project. The implementation phase will take place from July 2024 to June 2025.

Twenty-four lead artists/organizations applied in response to the Impact Pilot Guidelines. Of those applicants, seventeen met eligibility requirements. On November 30, 2023, the panel for the Impact Pilot convened to evaluate eligible applications using standard criteria and scoring. After evaluation of the applications and scoring, the panel voted to recommend ten applications for awards in the amount of \$100,000 each.

### NEXT STEPS

Following Policy & Funding Committee's recommendation, the Commission will receive and vote to recommend the Impact Pilot Tentative Awards. The City will begin the process of entering into agreements with the funding recipients for the Impact Pilot running from January 1, 2024 through June 30, 2025.

- 1. The AjA Project
  - a. In collaboration with Fatuma Fadhil
  - b. This collaborative project aims to nurture and amplify the hyperlocal culture emerging from the experiences of young immigrants in City Heights. The collaboration envisions itself as a professional mentorship program, artistic incubator, and cultural asset mapping/community learning initiative contributing to preserving and innovating of City Heights' unique cultural identity amidst rapid gentrification. While this project is a new initiative, it builds on the foundation of AjA's Back Alley Poetry Club and aligns with the "Arts + Sustainability" and "Arts + Just City" focus areas.
- 2. All for Logan
  - a. In collaboration with Hector Villegas
  - b. In a community that faces rapid threats of gentrification and the lack of spaces for arts and culture, the organization will host monthly art shows showcasing as many as 50 local artists along the main business corridor. The corridor space will act as a gallery and multifunctional community space as a part of the ongoing "Barrio Art Crawl," it will be open to host workshops, artist "platicas" and artwork sales. The organization is also working on creating a database of active Barrio Logan artists that will not only serve as a rolodex-type tool to pull from when approached by agencies, property owners, institutions, and other businesses as candidates to create work for designated projects. The project intersects with all three of the Impact focus areas.
- 3. Asian Story Theatre
  - a. In collaboration with William Virchis
  - b. This performance project aligns with Arts + Just City and will be developed from personal experience with the United States Census and exploring if prejudice or disinformation discourages or prevents people from participating in the Census, creating a self-perpetuating disadvantage. There are deeply held and reasonably argued differences of opinion surrounding the Census. How you answer the question of race can affect the Census experience. The organization's producing director was a 2020 Census door-to-door enumerator assigned to nearby San Diego Promise Zone addresses; he heard both comic and troubling reasons about avoiding the Census.
- 4. Kim Phillips
  - a. In collaboration with San Diego Sister Cities
  - b. The New Avenue: Digital Archives of African American & Chicano Heritage in Logan Heights is a transformative initiative aligned with the belief that art can catalyze change. This project aims to redefine Logan Heights' cultural landscape, addressing cultural erosion and responding to the neighborhood's unique challenges, including those within the San Diego Promise Zone and San Diego Communities of Concern. By documenting untold stories, particularly from elders outside traditional archives, the project breathes life into forgotten narratives, inspiring pride in predecessors and historic buildings. Community members share stories through lived experiences and an interactive archive, fostering healing, reconnection, and rediscovery of common bonds. This initiative transcends conventional arts projects, laying the foundation for a vibrant, connected, and just community. The project intersects with the Impact focus areas Arts + Heritage and Arts + Sustainability.
- 5. Little Saigon San Diego
  - a. In collaboration with Indochinese Association of San Diego
  - b. At twenty historical sidewalk markers in the Little Saigon District and City Heights featuring the rich history, stories, and events of early Vietnamese people and businesses visitors can learn stories of those who helped shape the community. Visitors are encouraged to explore further with links to websites that offer in-depth visual storytelling with embedded elements like images, data illustrations, videos, and blogs. The project will intersect with Arts & Heritage and Arts & Just City by bringing history and heritage alive to promote loving kindness and empathy.
- 6. San Diego Made
  - a. In collaboration with Space 4 Art
  - b. "My Creative Journey" | "Mi Viaje Creativo", is a new initiative that will enhance the visibility of creative success models through free public events and opportunities centered around a unique quarterly residency for four local artists. These artists will have deep connections to the San Diego Promise Zone communities and embody

traditional art practices and cultural insights. Each selected artist will receive free studio space at the Made Factory for their quarter of residency, a living wage stipend to facilitate their work and the support of both collaborating organizations' teams and resources. Each selected artist's residency will produce a public speaking event, a visit for local students, weekly 'office hours' for community engagement, and a final event presenting an art project. The project embodies Arts + Just City by uplifting local artists with deep roots in the San Diego Promise Zone communities.

- 7. South Bay Alliance Association Incorporated
  - a. In collaboration with John Roy Sound
  - b. This project will produce art, music and health wellness event(s) at local parks such as Chicano Park and or Cesar Chavez Park as well as a yet-to-be-determined Park in San Ysidro that is free to the public. The project is to feature a full production-managed stage for local and regional musical acts, poets, songwriters, and composers to perform on and to provide a SafeZone for the public to gather, for artists to exhibit artwork for sale, for HIV/HCV/HARM REDUCTION outreach, health testing, linkage to care and other services, promote environmental stewardship, civic engagement, and art and music education. The project will create an environment to foster living traditional and folk-art practices through these events in response to the Arts and Heritage Impact focus area.
- 8. The Urban Collaborative Project
  - a. In collaboration with Maxx Moses
  - b. "Shine Forever" encompasses the broader vision of what the organization feels is imperative for the success of our young people within the community. The project involves recruiting twenty-four teenagers who reside in the San Diego Promise Zone from Lincoln Park and Encanto. To develop participants into global citizens, the organization will teach them cultural competency, invite them to explore outside of their current identities, and include exploring across the city's diverse landscape where cultural differences and different art forms can be embraced. It will conclude with a youth-led community exhibition with diverse local community members. The project aligns with the Impact focus areas Arts+Sustainability and Arts + Just City.
- 9. WorldBeat Cultural Center
  - a. In collaboration with Centro Cultural de la Raza
  - b. This project will engage the community in the designing of the Cultural Plaza between WorldBeat Cultural Center and Centro Cultural de la Raza. Programming and events will engage the local community and encourage cultural exchange. Strategic partnerships with local businesses and community organizations can provide support and increased visibility. Ensuring communities from throughout the city that are traditionally underrepresented in Balboa Park will prioritize Arts + Heritage and the sustainability of living traditional and folk-art practices by gathering these communities at the Cultural Plaza.
- 10. Tu y Yo Theater
  - a. In collaboration with Veronica Marquez
  - b. The project, "Mitos," is a dynamic fusion of immersive theater, historical research, and community engagement that aims to create a visual counter-history of community cultural wealth in San Diego's Communities of Concern. The organization conducts in-depth research into pivotal moments in the community's struggle for justice and equity that will serve as the foundation for the immersive theatrical experience and an accompanying exhibition. Audiences will be transported into the heart of historical events such as The Lemon Grove Incident, the Founding of Chicano Park, and local activism by members of the Asian American and Pacific Islander community. "Mitos" intersects with the Impact focus area of Arts + Sustainability in several significant ways.

### PUBLIC ART COMMITTEE RECOMMENDATION:

Recommend the following panelists for the *here comes the neighborhood: Encanto* Public Art Project: 1) Denise Rogers with Commissioner Imani Robinson as an alternate for the seat of the Public Art Committee Member, 2) Gaidi Finnie for the seat of the Visual Art/Design Professional #1, 3) Lani Bautista Cabanilla for the seat of the Visual Art/Design Professional #2 with recommended alternates, in no particular order, to serve as three of the five ad hoc artist selection panelists.

#### SUMMARY:

City staff will administer the artist selection process for *here comes the neighborhood* public art initiative. The artists selected for the second iteration of *here comes the neighborhood* through the competitive process will work with the City to create permanent, visually engaging and conceptually rich artworks for the Encanto neighborhoods in and around the San Diego Black Arts and Culture District. Up to three artists will be commissioned. The anticipated artist fee for each artist in the second iteration is \$40,000.

In alignment with *here comes the neighborhood* project plan, the artist selection panel for the second iteration will be composed of five voting members: a Public Art Committee member, two visual art/design professionals, a Planning Department representative, and a community representative, City staff members will attend the panel meetings as non-voting advisors. The Public Art Committee is authorized to recommend appointment of three of the five panel seats for the public art project.

In January of 2021, the PAC and Commission took action to recommend three of the five panel seats as described for the *here comes the neighborhood: Encanto* initiative. Delays to this initiative were incurred primarily due to the emergency implementation of the *SD Practice* and *Park Social* artist relief initiatives over the course of and emerging from the COVID-19 pandemic. In the intervening time, the PAC members recommended in January of 2021 to serve as panelists and alternates no longer serve as members of the PAC. Additionally, the Visual Art/Design professional recommended for Panel Seat 2 in January of 2021 is no longer able to serve. On December 8, 2023, the Public Art Committee voted (8,0,0) to recommend the following updates for panel seats:

#### <u>Panel Seat 1</u>

Denise Rogers, which Commissioner Imani Robinson as an alternate

#### Panel Seat 2

Gaidi Finnie, Executive Director of the San Diego African American Museum of Fine Arts

**Gaidi Finnie** is the Executive Director of the San Diego African American Museum of Fine Arts. Finnie has a diverse and lengthy career in service of San Diego's arts and culture sector, including having served as a member of the board of directors or in management positions with North Coast Repertory Theatre, the Museum of Photographic Arts, Balboa Park Conservancy, and the Port of San Diego's public arts committee. With the San Diego African American Museum of Fine Arts, Finnie has organized

numerous exhibitions, many in collaboration with partner institutions throughout San Diego. These include the San Diego iteration of the *Say Their Names Memorial*, *Black Life: Images of Resistance and Resilience in Southern California* in collaboration with the San Diego Museum of Art, *Legacy in Black* in collaboration with the San Diego History Center, and *Dimensions of Black* in collaboration with the Museum of Contemporary Art, San Diego, among many others. In 2020, Finnie served as an artwork selection panelist for the City's *SD Practice* collecting initiative.

### Panel Seat 3

Lani Bautista Cabanilla, Manager, Community Impact, The San Diego Foundation

Lani Bautista Cabanilla is an arts administrator and community organizer with over 15 years of experience serving the arts and culture field. She was recently appointed as a Manager of Community Impact at The San Diego Foundation. Prior to that, she served as Senior Manager, Programs at The New Children's Museum in San Diego, where she collaborated with artists and community partners to develop innovative projects and installations that welcome over 250,000 children and families annually. In the last decade, Cabanilla has created arts education programs for five thematic exhibitions and curated dozens of hands-on studio experiences. Prior to joining the museum in 2008, she worked in community-based education programs, at independent design firms and on set-design projects in Los Angeles. Cabanilla has a BA in Art from San Diego State University, an AA in Visual Communications from The Fashion Institute of Design & Merchandising and studied Human-Centered Design at The Design Academy. She also serves as a Board Member and Managing Director for Made in Paradise Hills – PH Night Market in Southeast San Diego.

# San Diego Commission for Arts & Culture Advocacy Committee Advocacy Priorities 2024

### VISION: Expanding our world by celebrating creativity on San Diego

PURPOSE: The City of San Diego Commission for Arts and Culture serves in an advisory capacity to the Mayor and City Council on promoting, encouraging and increasing support for the region's artistic and cultural assets, integrating arts and culture into community life and showcasing San Diego as an international tourist destination.

### PUBLIC FUNDING FOR THE ARTS

We advocate for the restoration of reduced arts funds, maintenance of existing funding, and support increased funding and resources for public arts and culture agencies, nonprofit arts organizations, and individual artists, to advance and drive an equitable and inclusive creative economy, specifically:

- Increase Arts & Culture Funding from the city's Transient Occupancy Tax (TOT) to equal 1 cent out of the 10.5 cent TOT, as described in the "Penny for the Arts Five Year Blueprint" approved by the City Council in 2012.
- Provide and expand a variety of Arts & Culture funding mechanisms, such as Impact, to support emerging artists, expand access to arts and culture throughout the city, address systemic challenges in arts and culture ecosystems and transform historically underserved communities through the arts.
- Increase funding to support administrative oversight and program management to extend program reach and help community organizations applying for funds.

### ADVOCACY PLAN

Communicate Commission advocacy priorities to the mayor and members of the City Council:

• Meet with councilmembers and mayor formally and informally throughout the city budget process.

Identify and engage with artists and cultural organizations, both City funded and independently funded, in our neighborhoods, council district and city-wide, to seek advice, receive input and participate in the advocacy process.

Participate in advocacy actions with other local and state arts advocacy organizations such as San Diego Regional Arts & Culture Commission (SDRACC), San Diego Arts+Culture, Californians for the Arts, California Arts Council, and National Council for the Arts.

We anticipate the Mayor's Creative City Cultural Plan will provide a funding priority framework when it is presented in winter 2025.
