# NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - Martin Luther King Jr. Parade, 5k Run Walk and Festival

**COMMUNITY PLAN AREA:** Downtown

**COUNCIL DISTRICT: 3** 

**LOCATION:** Harbor Drive, Broadway, Pacific Highway, Ruocco Park

**PROJECT DESCRIPTION:** Special Event Permit for the Martin Luther King Jr. Parade, festival, and 5K run/walk that would include marching units, school bands, civic groups, floats, vehicles, stages, generators, tables, chairs, tents, music, sound amplification, onsite food preparation, food trucks, portable restrooms, and trash/recycling containers. The parade and race would occur on Harbor Drive, Broadway, Pacific Highway (see attached maps and routes), and the end of the race route and festival will take place at Ruocco Park. Noise associated with the event activities and set-up/dismantling would occur from 3 PM on January 12, 2024, until 5:30 PM on January 14, 2024. Set-up would occur from 3 PM until 5 PM on January 12, 2024. On January 14, 2024, the event would occur from 6 AM until 5:30 PM, and dismantling would occur from 4 PM until 5:30 PM.

Road closures associated with this event would be as follows on January 14, 2024: Harbor Drive between W Grape Street and Pacific Hwy. from 7 AM to 1 PM, W Broadway between Harbor Drive and Pacific Highway from 7 AM to 1 PM, Pacific Highway from W Broadway to Harbor Drive from 7 AM to 1 PM. Ash St. from Pacific Hwy. to Harbor Dr. from 7 AM to 1 PM Additional no parking would include the West curbline of Pacific Hwy. from Grape Street to Admin Building for participant bus unloading and would occur from 7 AM to 1 PM.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.



## Martin Luther King Jr. Parade, 5k Walk/Run

### Route / Site Plan

# 5k Run / Walk:

- 1. Begin staging 5k at Grape and Harbor Dr. Ash St. Sunday, 1/14 @7am. 5k Walk/Run begins 9:30am.
- 2. 9:30am begin 5k southbound on Harbor Dr.
- 3. Turn left onto W. Broadway. (~9:45am)
- 4. Turn right on Pacific Hwy. (~9:50am)
- 5. Cross Harbor Dr. at "Dead Mans Point". (10:00am)
- Use sidewalks next to and behind Ruocco Park and Embarcadero along waterfront to South Embarcadero and back to Ruocco Park for the finish. (~10:30am)
- 7. Walking takes ~1 hr for the 3.1 miles per Google Maps.
- 8. Parade to begin on same route at 10am, but will end on Pacific Hwy near Embassy suites for the disbanding area ~12:30pm. See info. below. No need for the parade to use Embarcadero sidewalks.
- 9. Moving portions of event ends ~12:30pm.
- 10. We'd like to use Ruocco park for a festival at the end of the 5k and Parade until 5pm.



Parade route: 7am - 10am staging, parade procession 10am - ~12pm

- 1. Begin staging parade and 5k at Grape and Harbor Dr. Ash St. Sunday, 1/14 @7am.
- 10am begin parade Southbound on Harbor Dr.
- 3. Turn left onto W. Broadway, going east. ~10:10
- 4. Turn right on Pacific Hwy, going south. ~10:15
- 5. Disband on Pacific Hwy near Embassy Suites. Between 10:30 1pm.
