## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit - 14th Annual Dr. Martin Luther King Jr. Community Celebration
Sportsfest & Parade
COMMUNITY PLAN AREA: Southeastern San Diego
COUNCIL DISTRICT: 4

**LOCATION:** Skyline Drive between Churchward St. and Martin Luther King Jr. Recreation Center & Park

**PROJECT DESCRIPTION:** Special Event Permit for a parade and sports festival event that would include marching units, school bands, civic groups, floats, cars, a kids zone, sports activities, entertainment, sound amplification, food and merchandise vendors, food trucks, onsite food preparation, and the temporary use of a stage, a generator, fencing/barriers, tables, chairs, that would occur on Skyline Drive between Valencia Parkway and MLK Park on January 20, 2024. The festival would take place on the east side of the swimming pool and the sportsfest inside the gym. Noise associated with the event activities and set-up/dismantling would occur from 6 AM until 6 PM on January 20, 2024. On January 20, 2024, set-up would occur from 6 AM until 9 AM, the event would occur from 9 AM until 4 PM, and dismantling would occur on from 4 PM until 6 PM. The parade route would begin at Valencia Park Elementary and head east on Skyline Dr. to the Dr. Martin Luther King Jr. Park. See map attached.

Road closures would be associated with this event and would occur on January 20, 2024, on Valencia Parkway between Skyline and Latimer from 6:30 AM and 11 AM, and Skyline Drive between Valencia Parkway and 65<sup>th</sup> Street from 7:45 AM until 11 AM.

Parking closures would be associated with this event and would occur on January 20, 2024, from 6:30 AM to 11 AM and would include both sides of Valencia Parkway between Skyline and Latimer, both sides of Skyline between Valencia Parkway and S. 65<sup>th</sup> Street.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

## **Parade Route and Timeline**

6:00am: Set Up— Valencia Park Elementary Joint Use Parking Lot and Field.

🗕 8:00am: Assemble — All participants, bands, and groups report to Valencia Park Elementary Parking lot off Valencia Parkway.

9:00am: Parade Starts—All participants exit parking lot and head south on Valencia Parkway, turn east on Skyline Dr. and continue on until reaching MLK Rec at 6401 Skyline Dr.

11:00am: Parade Ends at MLK Rec center, all participants enter the MLK Park or breakdown area east of MLK park on Skyline Dr.

11:00am: MLK Day Celebrations kick off.

Road Closures - 7:00am-11:00am

Skyline Dr. at Valencia Parkway – North Entrance to Ozzie Way – S. 61st St at Skyline Dr. – Entrance to O'Farrell Charter School – North Entrance to Omeara St. – South Entrance to Henson St. – South Entrance to Patten St. – Detroit Pl. – Skyline Dr. at 61st St.
