- a. Community Planners Committee update: No meeting held in December. January 24th will be next meeting 6-7:45. City Council Policy 600 will be bringing major changes encouraged to look into.
- b. BLPG Sub Committees: No Plans to review for review committee.
- c. Other updates/announcements: CPMCC is at the top of the list for housing BLPG meetings. John suggested Don Diego.
- d. John: Sailing class will begin to help young people how to sail. Will also have a new program to help people get their power boat license.
- e. Julie: MCC called meeting at Our Lady of Guadelupe. Will provide additional information on next meeting once received.
- 8. Action Information Item: MAAC Mercado Apartments Development (15 min presentation / 10 min Q&A)
 - a. Oscar Del Toro: MAAC has been dedicated itself to helping low income housing. Proposing a 100% affordable housing project.
 - **b.** Gil Martinez: Architect of Cesar Chavez Continuing Education. Hiring students from UC Berkely to help with planning process.
 - c. 92 total units. 1,2,and 3 bedrooms. City Parking requirements are made. Commons are and courtyard area added.
 - d. Focus on families not car housing.

- e. Trying to keep it low 4 stories. Dilemma is that they are surrounded by industrial.
- f. 4th level will have projecting platform looking out to the bay.
- g. Plans were not received on time but questions will be taken.
- h. David Ortiz: Where is the parking for all the residents? No parking for residents. Extreme shortage of parking. Oscar: cost of additional parking makes project cost prohibitive. Cant prioritize parking over housing. Tough choice to make. David: Hesitant that it will become a cluster. Curious of what residents of garden homes will say to this. Oscar: we have talked to the residents and they strategically are located next to a trolley. Public amenities are close by also. David: requested additional renderings. Each unit has balconies. Engagement with public is encouraged.
- i. Kenny: Project looks nice but concerns of parking issues.
- j. Philomena: Is this intended to be called the projects. No.
 - i. Are you proposing the 30% approved in the plan. All are affordable.
 - ii. Please clarify if there will be a space for those who are not residents. They are not certain. Suggested sending a letter to CEO of MAAC.
 - iii. Parking has been mentioned. Is project working with SANDAG in regards to trolley. Long trips to commute to La Jolla. Project cannot alleviate all of the problems.
 - iv. David: We are just trying to figure out how much of a cluster will be created in the community.
 - v. 45 bike spaces, 9 motorcycle parking.
 - vi. Matt: Shares concerns of David, John, Philomena. Worried about losing parking for quality of life issues.
 - vii. Julie: We are dying for housing. Her brother got an eviction notice and has no where to go. Father finally got senior housing after 12 years. People are desperate for housing. Parking issue is real but 92 bedrooms is substantial. We are pushing at these tables MTS and Sandag. We need to remember who we are representing in this community.
 - viii. David Duea: What is the address: 2001 Newton Ave SD, CA 92113
 - ix. Julie: Is it possible to make it walkable on the bottom level.
