San Diego, Chula Vista, National City Police Announce New Program to Help Drivers Fix Burned Out Lights AGENCIES WILL JOIN OTHER CITIES NATIONWIDE OFFERING VOUCHERS IN LIEU OF CITATIONS FOR LIGHTING EQUIPMENT VIOLATIONS

San Diego – Bringing innovative solutions to the San Diego region to improve police-community relations and lessen the burden of certain traffic tickets, San Diego, Chula Vista and National City Police Departments announced today that they would be joining agencies nationwide to implement the <u>Lights</u> <u>On! program</u> in their communities.

Lights On!, a program developed by Minneapolis-based nonprofit MicroGrants, partners with law enforcement and auto service providers to replace traffic tickets with repair vouchers. The vouchers fix the bulbs, improve safety, and mitigate what could become a downward spiral for lower-income residents. SDPD, Chula Vista and National City will be the first agencies in California to offer the program.

The agencies have partnered with the San Diego Padres Foundation and Scripps Health to fund the initiative, and all donations made to Lights On! are matched by MicroGrants. The Padres and Scripps' donations will allow all three agencies to operate the program for approximately three years, depending on the cost of repairs and redemption of vouchers.

Once the vouchers arrive, officers from all three agencies will conduct traffic stops for lighting equipment violations just as they always have, but instead of issuing a citation or "fix-it ticket," they will offer

motorists a Lights On! voucher and explain how they can redeem it. Officers will begin issuing vouchers in the coming weeks.

While officers will be issuing vouchers for the lighting equipment violations, they will still be able to act on other violations that may be present. It does not prohibit them from requesting the person's identification and checking police databases for any outstanding warrants.

Vouchers can be redeemed at participating locations for up to \$250 for burned-out headlights, taillights, brake lights and turn signals. If the repairs total more than \$250, the remaining amount is the sole responsibility of the driver. If the participating auto service provider cannot complete the repairs due to another issue with the vehicle, the repairs will be the responsibility of the driver. The voucher cannot be redeemed for cash value.

Each agency has identified participating auto service providers to complete the repairs in their jurisdictions. Auto repairs are invoiced by the repair shops and reimbursed with the funding provided by Scripps and the Padres. Local auto service providers are invited to join the program.
