Priorities and Strategies

Goal: Increase access to healthy foods and healthcare

- **Objective I:** Increase access to healthy foods
 - **Priority i:** Identify and pursue funding opportunities to support urban agriculture projects
 - A. Connect Partners for a collective application to the Community Food Initiative Grant Program
 - **Priority ii:** Increase development and utilization of community gardens in all types of parks
 - B. Promote the updated land-use code which allows community gardens in Open Space parks
 - C. Work to expand the land-use code to allow community gardens in other types of parks
- **Objective II:** Improve access to healthcare
 - **Priority iii:** Re-engage health agencies and service providers
 - D. Identify and on-board a third co-chair to represent this objective
 - E. Promote health related resources to Promise Zone residents
- **Objective III:** Support opportunities for active transportation and active living
 - **Priority iv:** Support the development and implementation of active transportation and active living policy efforts
 - F. Work to update the Parks Master Plan to include safe sidewalks requirements within a specified distance of all parks
 - G. Support Quick Build projects in priority routes within the Promise Zone area
 - H. Support partners' understanding and promote Placemaking permits
