

Dear **Kelly Archer**,

Your election for an exemption renewal from the Laborers Apprenticeship Ratio has been approved. As you know, under this Exemption you must have an apprentice on the job on any day that you have more than three Laborer journeymen on the job. The Southern California Laborers Joint Apprenticeship Committee is now reviewing all exemptions, and reserves the right to revoke any and all exemptions if it determines that they are not in the best interests of the apprentices.

If it is determined that your company performs the type of work where apprentices should be employed routinely under the normal ratio, your exemption may be revoked and your company would then operate under the ratio set forth in the Laborers Apprenticeship Standards. In the meantime, the exemption for your company is in effect as of **08/01/2018** and is valid until December 31st of this year, and shall continue for each calendar year during the term of the Master Labor Agreement, unless the Training Trust notifies you that the Exemption is revoked. The DAS has been so notified.

We suggest you retain this letter so that if your records are reviewed by an awarding agency, a labor compliance program or the DAS, it can be produced to the reviewing entity. The reviewing agency should contact my office to inquire about whether the Exemption is still in effect.


