# **STAFF REPORT**

Suzanne Segur, Senior Planner from the Planning Department reported that the appeals of the historical designations of the Fred Rohr/ Ralph L. Frank House (HRB Site #1492) located at 555 San Fernando Street and the Mamie and Oliver Evans/ William Templeton Johnson House (HRB Site #1493) located at 4388 Ampudia Street, were heard by the City Council on November 7<sup>th</sup>. The appeals were not granted by Council and the designations were upheld.

The appeals of the historical designation of the Donald and Gladys Clitsome/Lloyd Ruocco House (HRB Site #1491) located at 2228 33<sup>rd</sup> Street and the Velma Prichard Spec House #1 (HRB Site #1503) located at 4321 Alder Drive were scheduled to be heard by City Council on November 14<sup>th</sup>; however, these items have now been rescheduled to December 5<sup>th</sup>. Boardmembers are encouraged to attend the appeal hearings to speak on behalf of the Board's action.

An appeal was filed after the October HRB meeting for the designation of the Robert and Clara West Spec House #1 located at 3441 Cooper Street. Staff will be actively working on bringing this property forward to the City Council for resolution in the new year.

THIS DESIGNATION SHALL EXCLUDE THE 1996 SOUTHWEST ADDITION AND THE ENCLOSED SLEEPING PORCH. Seconded by Boardmember Abrams.
