## **REVISED** NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**PROJECT NAME:** Park Use Permit – Korea in Color On Steps at SDMA **COMMUNITY PLAN AREA:** Balboa Park **COUNCIL DISTRICT:** 3 **LOCATION:** Plaza de Panama

**PROJECT DESCRIPTION:** A Park Use Permit for an art event on February 3, 2024, in Balboa Park's Plaza de Panama. The event would include vendors, performances, tables, stanchions, tents, and sound amplification. Noise associated with the event would occur on February 3, 2024, from 10 AM to 6 PM. Set up would occur from 10 AM to 12:30 PM, the event would occur from 1 PM to 5 PM and dismantling would occur from 4:30 PM to 6 PM.

There would be no road closures associated with this event.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in

publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
