NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Jog-A-Thon **COMMUNITY PLAN AREA:** Downtown **COUNCIL DISTRICT:** 3 **LOCATION:** 14th Street between E and F Street

PROJECT DESCRIPTION: Special Event Permit (SEP) to allow jog-a-thon event that would include students jogging laps in a circuit that would occur Downtown on 14th Street between E and F Streets on February 28, 2024. Noise associated with the event activities and set-up/ dismantling would occur from 8 AM until 12 PM on February 28, 2024. A sound system would be used for making announcements/motivate runners and sound amplification would occur from 9 AM until 11:30 AM. On February 28, 2024, set-p would occur from 8 AM until 8:30 AM, the jog-a-thon would occur from 9 AM until 11:45 AM, and clean-up/dismantling would occur from 11:45 AM until 12 PM. The jog-a-thon route would be a circuit along both sides of 14th Street between E and F Street. Approximately 400 attendees are anticipated during the event.

A road closure associated with this event would occur from 8 AM until 12 PM on 14th Street between E and F Street. Parking along those streets will also be prohibited from 8 AM to 12 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
