## HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

<u>In Person for Agenda Items and Non-Agenda Public Comment:</u> Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

<u>Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:</u> When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

**Please Note:** Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

Those participating virtually may NOT cede time to others participating in person or virtually.

## **HOW TO PROVIDE WRITTEN COMMENTS:**

For Agenda Items and Non-Agenda Public Comment: Submit using the webform, indicating the comment type and item number (if relevant). Comments must be submitted the business day prior to the meeting to be distributed to the Hearing Officer and posted online with the meeting materials. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer website for further instructions.

<u>Written Materials:</u> Instead of submitting materials as an attachment to the <u>webform</u>, you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

# **Late-Arriving Materials:**

# ITEM 1: 7964 LOWRY TERRACE - PROJECT NO. 1080285

Staff: May Rollin City Council District: 1 Plan Area: La Jolla

Site Development Permit and Coastal Development Permit for the demolition of an existing single-story dwelling unit and existing site improvements; and the construction of a single-story 3,733-square-foot single-dwelling unit with associated site improvements, located at 7964 Lowry Terrace. The 0.24-acre site is in the LJSPD-SF base zone (La Jolla Shores Planned District-Single Family zone) and within the Coastal Overlay zone (Non-Appealable Area 2), Coastal Height Limit Overlay zone, Parking Impact Overlay zone (Beach Impact), Transit Area Overlay zone, Transit Priority Area, and the Complete Communities Mobility Choices – Mobility Zone 2 of the La Jolla Community Plan area. The project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA State Guidelines, Section 15303, New Construction or Conversion of Small Structures. Report No. HO-24-001.

## ITEM 2: TWO AMERICA PLAZA - PROJECT NO. 1076060

**Staff:** Jacob Basinger **City Council District:** 3 **Plan Area**: Downtown

Tentative Map Waiver to create 48 residential condominiums and two (2) commercial condominiums for a 13-story mixed-use development on a single lot at 1111 Kettner Boulevard approved under Centre City Development Permit/Centre City Planned Development Permit/Neighborhood Use Permit No. 2018-58. The 65,317 square-foot Project site is located on the south side of West B Street between Kettner Boulevard and India Street within the Core land use district of the Centre City Planned District, the Employment Overlay and Transit Priority Area Overlay, the Columbia neighborhood of the Downtown Community Plan area, and Council District 3. The Project is within the scope of the previously certified <a href="Downtown Final Environmental Impact Report">Downtown Final Environmental Impact Report</a> as amended and no additional environmental document is required under the California Environmental Quality Act. <a href="Report No. HO-24-003">Report No. HO-24-003</a>.

# **ITEM 3: 7443 EADS AVENUE - PROJECT NO. 1070073**

Staff: Blake Sonuga City Council District: 1 Plan Area: La Jolla Coastal Development Permit and Map Waiver to demolish an existing garage, construct a new 3,327-square-foot dwelling unit with a 950-square-foot Accessory Dwelling Unit (ADU), add a 286-square-foot Junior ADU to an existing 1,556-square-foot dwelling unit, and create two condominium units, each with an ADU. The 0.16-acre site is located at 7443 Eads Avenue in the RM-1-1 (Residential Multiple Unit) Zone, the Coastal Overlay Zone (Non-Appealable Area 2), and the Coastal Height Limitation Overlay Zone within the La Jolla Community Plan. This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15303 (New Construction or Conversion of Small Structures).
