HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment:

Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to the Chairperson at the box indicated near the speaker's lectern at the front of the room.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:

When the Chairperson introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by dialing ***9** on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Chairperson indicates it is your turn to speak, unmute your phone by tapping the Unmute button on your computer, tablet or Smartphone, or dial ***6** on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. ITEM 1: *BISHOPS SCHOOL AMENDMENT- PROJECT NO. 0698140

Staff: Oscar Galvez III City Council District: 1 Plan Area: La Jolla

Public Right-of-Way (Alley) Vacation, Coastal Development Permit , an amendment to Coastal Development Permits No.10728 and 518943, a new Conditional Use Permit, an amendment to Conditional Use Permit 518944; a Planned Development Permit, an amendment to Planned Development Permit No. 80680, and a Site Development Permit an amendment to Site Development Permit No. 10727 to update the Master Plan for The Bishop's School located at 7522 and 7554 Draper Avenue and 7607 La Jolla Boulevard. The proposed phased development includes (Phase 1) new batting cages and practice field, (Phase 2) new three-story, 27,762 square foot Creative Science Building / Athletics Building, (Phase 3) new three-story, 29,689 square foot Athletic Center and one-story 653 square foot tennis pavilion, (Phase 4) new three-story, 13,120 square foot Athletics Building / Creative Science Building. The 11.3-acre site is located in La Jolla Planned District 5 and 6 Zone, Coastal (Non-Appealable) Overlay Zone, and the Coastal Height Limit and Parking Impact (Beach) Overlay Zones within the La Jolla Community Plan and Council District 1. Addendum No. 698140 to Mitigated Negative Declaration No. 6162 was prepared pursuant to the California Environmental Quality Act Guidelines section 15164 since only minor technical changes and additions were necessary. No substantial changes have occurred with respect to the circumstances under which the project is undertaken, and there is no new information of substantial importance to the project. A Mitigation, Monitoring, and Reporting Program for Historical Resources (Archaeology) will be implemented. <u>Report No. PC-24-001</u>

Tentative Map and Site Development Permit to amend Site Development Permit No. 1442449 to subdivide a 2.79-acre site to create two lots to construct a 2,550-square-foot single dwelling unit (SDU) with 1,200-square-foot Accessory Dwelling Unit (ADU) on the western lot, and a 3,150-square-foot SDU with 1,200-square-foot ADU on the eastern lot. The undeveloped site is located at 11275 Beeler Canyon Road in the RS-1-8 Zone within the Rancho Encantada Community Plan area.
