Presented Informational Item 1: The City of San Diego has provided a summary of the Texas Street Substantial Conformance Review (SCR) PRJ-1104896 as an "after the fact" review of the project: Scope: a Substantial Conformance Review application for emergency maintenance completed under Approval No. PMT-3209979 (PRJ-1087425) in an earthen stormwater drainage ditch located on the east side of Texas Street between Adams Avenue and Camino Del Rio South. The approximately 0.04-acre area of drainage is in the Residential Single Dwelling


Unit (RS-1-1) and Commercial Office (CO-2-2) Base Zones, of the North Park Community Plan.

b. Presented Informational Item 2: The City of San Diego established an ongoing program for the replacement of all aging and deteriorating water mains currently in service. These replacements will reduce future water main breaks and reduce maintenance requirements. The program will also bring the existing water mains up to current City Standards.

Project Overview: North Park Improvement 2 Project will replace approximately 2.31 miles (12,217 feet) of water distribution mains.

Construction Schedule: This project will occur in various stages throughout your community approximately beginning in August 2024 and approximately ending in May 2026.
