A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ADOPTING THE GOALS FOR THE CITY OF
SAN DIEGO U.S. DEPARTMENT OF HOUSING
AND URBAN DEVELOPMENT PROGRAM'S FIVE-
YEAR CONSOLIDATED PLAN FOR FISCAL
YEARS 2025 THROUGH 2029.

WHEREAS, the City of San Diego (City) is an entitlement jurisdiction that annually receives federal funds through four U.S. Department of Housing and Urban Development (HUD) housing and community development entitlement programs: Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), Emergency Solutions Grants (ESG), and Housing Opportunities for Persons with AIDS (HOPWA) (collectively, HUD Programs); and

WHEREAS, HUD requires the City to prepare a Consolidated Plan (Plan) every five years for the City to receive federal housing and community development funding under the HUD Programs; and

WHEREAS, the purposes of the Plan include (1) identifying the City's housing and community development needs, priorities, and goals; (2) identifying other federal, state, county, local, and private sources of funding; and (3) establishing a strategic plan for the City to address such needs, priorities, and goals while considering the availability of other resources and mechanisms; and

WHEREAS, the City is required to prepare a new Plan for Fiscal Year (FY) 2025 through FY 2029 that must be submitted to HUD for review and approval on or before May 15, 2024; and

WHEREAS, the City is developing its Plan for FY 2025 through FY 2029 in consultation with the intended primary beneficiaries of the HUD Programs, the community, adjoining jurisdictions, and non-profit, for-profit, and faith-based community organizations; and

WHEREAS, the process of developing the City's Plan for FY 2025 through FY 2029 includes assessing community needs, setting goals, and developing strategies to address priority needs and objectives; and

WHEREAS, the goals and objectives established in the Plan for FY 2025 through FY 2029 will direct the funding for the HUD Programs during this time period; and

WHEREAS, the Council of the City of San Diego (City Council) must approve the goals for the Plan for FY 2025 through FY 2029 to direct completion of the Plan; and

WHEREAS, the Office of the City Attorney has drafted this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council, that the following goals are adopted for the City's Plan for FY 2025 through FY 2029:

1. Increase, protect, and preserve affordable rental and homeownership housing opportunities by improving access to a diverse set of affordable housing, accessible in design and energy efficient, with proximity to job centers, schools, parks, and services.
2. Invest in inclusive economic growth initiatives that develop and strengthen small businesses, support local entrepreneurs, expand employment and/or workforce development programs, and improve access to job opportunities.
3. Develop vibrant and equitable neighborhoods by investing in public facilities,

critical infrastructure, and/or nonprofit facilities that provide increased accessibility, resiliency, and sustainability.

4. Improve housing stability for individuals and households with critical needs, including persons experiencing or at-risk of homelessness by providing appropriate housing and service solutions grounded in best practices.

5. Improve community services by addressing critical needs and promoting equity through improved or increased access to community programming.
