There is a pending request to replace the two bleachers on the Penn T-ball field. Currently working on placing a monument sign at Boone Neighborhood Park. Adjustable rims were installed at Paradise Hills Recreation Center.
2. **Paradise Hills Recreation Center** – Kemii Soundara, Center Director I, reported that Paradise Hills Recreation Center is hosting 17u volleyball with 9 teams. Paradise Hills currently has 140 players for youth basketball this season.
