## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

PROJECT NAME: Special Event Permit - East Village Block Party

**COMMUNITY PLAN AREA:** Downtown

**COUNCIL DISTRICT: 3** 

**LOCATION:** J St. between 7th Ave & 10th Ave. (see attached map)

**PROJECT DESCRIPTION:** Special Event Permit for the East Village Association's annual Opening Day block party with the temporary use of a beer garden(s), stages, entertainment, a drone, car show, alcohol, onsite food preparation, food trucks, generators, sound amplification, vendors, fencing and/or barriers, portable restrooms, recycling and trash containers, tents, canopies, tables, and chairs that would occur on J Street between 7th Avenue & 10th Avenue on March 30, 2024. Alcohol would be served from 10 AM until 4 PM. Noise associated with the event activities and set-up/dismantling would occur between 3 AM until 11:55 PM on March 30, 2024. Sound amplification would occur from 9:30 AM until 4:30 PM for entertainment. Set-up would occur from 3 AM until 10 AM, the event would occur from 10 AM until 4:30 PM, and dismantling would occur from 4:30 PM until 11:55 PM. The expected number of attendees for the day would be approximately 3,500.

Road and parking closures would be associated with this event and would occur on J Street between 7<sup>th</sup> and 10<sup>th</sup> Avenues (bike lane also closed), 8<sup>th</sup> Ave. between J St. and Island, 9<sup>th</sup> Ave. between J St. and Island, from 3 AM until 11:45 PM on March 30, 2024.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
