NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - North Park Festival of Beers

COMMUNITY PLAN AREA: North Park

COUNCIL DISTRICT: 3

LOCATION: El Cajon Boulevard (southside) between Alabama and Texas Streets

PROJECT DESCRIPTION: Special Event Permit for a 21 and over fundraiser beer festival that would include alcohol, food vendors, food trucks, onsite food preparation, 50-60 locally based craft breweries, entertainment, a stage, sound amplification, a generator, portable restrooms, canopies, fencing and/or barriers, that would occur on April 6, 2024. Alcohol would be sold from 12 PM until 3:30 PM. Noise associated with the event activities and set-up/dismantling would occur from 6:30 AM until 6 PM on April 6, 2024. Set-up would occur from 6:30 AM until 12 PM, the event would occur from 12 PM until 4 PM, and dismantling would occur from 4 PM until 6 PM. Sound amplification from performances would occur from 10:30 AM until 3:45 PM.

Road and bike lane closures would be associated with the event and would include EB El Cajon Boulevard between Florida Street and Texas Street, Mississippi Street between El Cajon Boulevard and Howard Street, and Louisiana Street between El Cajon Boulevard and Howard Street from 7 AM until 6 PM on April 6, 2024.

Parking closures would me associated with this event and would include EB side of El Cajon Blvd. between Alabama and Texas Street, Louisiana St. between Howard Street and El Cajon Blvd., Mississippi Street between Howards St. and El Cajon Blvd., 40 ft on the SW corner of Alabama St. south of El Cajon Blvd., and 40 ft on the SE corner of Howard St., east of Alabama from 6 AM until 6 PM on April 6, 2024.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego

conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
