Dear District 2 residents,

On January 29th, 2024, the City Council approved Mayor Todd Gloria's State of Local Emergency in response to the storm that impacted San Diego. This storm caused lots of devastation to many residents in the Southcrest, Shelltown, Mountain View, and Encanto communities of Southeast San Diego.

Thank you, Mayor Gloria and to all of the City crews who responded during and after the storm, and who continue to work around the clock providing the much needed resources and assistance to those who are affected. A big thank you to both the City's public safety personnel who helped save lives during the flooding, and to the Environmental Services Department crews who have been out there every single day, including Saturday and Sunday, cleaning up and removing all of the trash and debris from the streets.

Another thank you to all of the volunteers, including members of my staff, who went to affected neighborhoods to assist with clean up efforts and who have donated items to those who lost all of their belongings. This will not be easy, especially with the storms that we will continue to experience, but with the assistance and the volunteerism from other San Diegans, we will do all that we can to continue assisting those who have been impacted.

I also wanted to point out that several emergency teams were deployed last Monday, during the storm, to areas within District 2 where residents and property were impacted and experienced flooding: Mission Beach, Ocean Beach, and Midway. While these areas did not experience the same level of impact that Southeast San Diego did, we still appreciate the response from our local public safety teams. The City of San Diego and County of San Diego are asking that everyone who experienced flooding and/or some sort of damage to their properties to **please fill out the County's survey** to help with data collection. **This is important so that San Diego could be able to secure additional funding and assistance from FEMA**. UPDATES FROM RECENT COUNCIL MEETINGS

Update on the Redevelopment of the City-Owned Property Located at the Sports Arena Area:

On Monday, January 23, 2024, the City Council received an update from the City's Real Estate Division and the Midway Rising team on this important project at the Sports Arena area in the Midway District (District 2). The project currently contemplates the development of up to 4,250 residential dwelling units -- 2,000 of which are affordable, a new arena, commercial/retail space, and more parks. Additionally, the Notice of Preparation was shared, and it became available for the community to provide input in January. This is the first step of the environmental review phase and will set the expectations for what the teams need to consider as they move forward with this project. Approval of the City of San Diego Project Labor Agreement (PLA) for City-Procured Capital Improvement Projects and Other Projects:

 Here at the City of San Diego, we care about fair wages and want to make sure we take care of our workers, especially those who are working on important capital projects. On Tuesday, January 30, 2024, the City Council approved the City's **Project Labor Agreement**. This agreement was made possible thanks to the passing of **Measure D** back in November of 2022, which I helped get on the ballot as the Chair of the Rules Committee in 2021. These negotiations initiated last year with the San Diego County Building & Construction Trades Council and crafts unions to cover City-procured Capital Improvement Projects, and then closed out earlier this month. This agreement will become effective July 1, 2024 and is set to be for a term of seven years.
