### **SUMMARY**

This report outlines updates being made to the City of San Diego's Parks and Recreation website. The focus of the presentation will be on introducing a new component featured on the Parks and Recreation website, the Design and Development webpage tab. This newest addition aims to provide a platform for the public to access important information and updates regarding ongoing park projects, planning documents, and opportunities for active engagement in the design process. The Design and Development webpage tab serves as a centralized hub for all matters related to the design and development of parks within the city.

## **BACKGROUND**

As the City of San Diego experiences continued growth, the importance of creating and maintaining vibrant and accessible parks becomes increasingly important. This initiative stems in the commitment to provide transparency, community involvement, and effective communication. Recognizing the significance of involving the community in the design and development process, we introduce this dedicated section on the Parks and Recreation website.

## **DISCUSSION**

The primary objective of this presentation is to introduce the Design and Development webpage tab to the Park Board. This feature on the website will allow users to explore and learn about park projects in their community.

The Design and Development webpage tab offers:

#### 1. Project information

a. The Design and Development tab features sections on current park projects and existing (in-service) parks. Users can easily access details on current and

upcoming park projects. This includes information dedicated to General Development Plans and Capital Improvement Program projects.

- 2. Public engagement opportunities
  - a. A key feature is the ability to keep the public informed about parks in the design and planning phases. The Design and Development tab includes informative project pages and a calendar highlighting upcoming committee meetings, allowing residents to participate in shaping the future of their community parks.
- 3. Access to planning documents.
  - a. The webpage tab includes documents and resources for those interested in the planning and design of parks. This resource allows stakeholders, including community members and project partners, with insights into the processes of designing our parks.
