NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – Corporate Event

COMMUNITY PLAN AREA: Mission Beach

COUNCIL DISTRICT: 2

LOCATION: South Mission Beach (adjacent to the lifeguard tower), 700 N. Jetty Road, San Diego, CA

PROJECT DESCRIPTION: Special Event Permit for a private event that would include entertainment, vehicles on beach, lifeguards, faux rocks, fire boats in water, sound amplification, and the temporary use of tents, temporary structures, fencing and or barriers, drones, restroom trailers, generators, food, onsite food preparation, alcohol, beer garden, trash/recycling containers, table, and chairs, that would occur at South Mission Beach and parking lot close to lifeguard tower and station on April 9, 2024. Majority of activities would be located in the parking lot including the beer garden and food elements. Alcohol would be served from 6 PM until 9:30 PM. Noise and sound amplification associated with the event activities and set-up/dismantling would occur from 7 AM on April 7, 2024, until 5 PM on April 10, 2024. Set-up would occur over three days, from 7 AM until 7 PM on April 7, 2024, from 7 AM until 9 PM on April 8, 2024, from 7 AM until 6 PM on April 9, 2024. The event would occur from 6 PM until 10 PM on April 9, 2024, and dismantling would occur from 7 AM until 5 PM on April 10, 2024.

Parking closures would be associated with the event and would include the South Mission Beach parking lot near the lifeguard stand and station, and would occur from 7 AM on April 7, 2024, until 5 PM on April 10, 2024.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing,

licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
