NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – San Diego Beach and Bay Half Marathon

COMMUNITY PLAN AREA: Mission Bay Park and Mission Beach

COUNCIL DISTRICT: 2

LOCATION: Tecolote Shores South Park, Mission Bay Park and Mission Beach; Fiesta Island

PROJECT DESCRIPTION: Special Event Permit for a half marathon race event that would include the half marathon route, the 5K and 10K routes, a fenced-in beer garden, tents, barriers, vendors, food trucks, onsite food preparation, entertainment, sound amplification, three stages, portable restrooms, canopies, and trash/recycling containers that would occur within Mission Bay on April 14, 2024. Sound amplification from performances would occur from 6 AM until 12 PM on April 14, 2024. Alcohol would be served from 8:30 AM until 11:30 AM. Noise associated with the event activities and set-up/dismantling would occur from 9 AM on April 13, 2024, until 2 PM on April 14, 2024. Set-up would occur from 9 AM until 6 PM on April 13, 2024, and from 3 AM until 5:30 AM on April 14, 2024. The event would occur from 5:30 AM until 12 PM on April 14, 2024, and dismantling would occur on April 14, 2024, from 12 PM until 2 PM. The half marathon, 5K and 10K routes are shown on the attached maps. The event start and finish lines are at Tecolote Shores Park, 1344 East Mission Bay Drive.

Road closures would be associated with the event on April 14, 2024, and would include the following: Fiesta Island closed to vehicle traffic from 4 AM until 9 AM; East Mission Bay Drive at Fiesta Island from 3 AM until 10 AM; from 4 AM until 10 AM E. Mission Bay Drive between Sea World Drive to Tecolote Shores south parking lot, Westbound Sea World Drive at E. Mission Bay Drive, Crown Point Drive from Lamont Street to Pacific Beach Drive; Corona Oriente no access to entrance of North Crown Point Park Parking Lot, and S. Shores from 4 AM until 10 AM; Public parking would also be prohibited from 3 AM to 12 PM on April 14, 2024, for Tecolote Shores South parking lot. From 4 AM until 2 PM on April 14, 2024, entrance to dirt parking lot at Fiesta Island entrance, both East and West curb lines of East Mission Bay Drive between Tecolote Shores Parking lot entrance Sea World Drive, both North and South curb lines of San Rafael, from boardwalk to the bay side, south curb line of Crown Point Drive from Lamont Street to Pacific Beach Drive, south curb line of Pacific Beach Drive from Crown Point Drive to Camp land entrance, west curb line of North Mission Bay Drive from pedestrian walkway to De Anza Trailer Park entrance.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
