NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit - Sunday Funday COMMUNITY PLAN AREA: Uptown COUNCIL DISTRICT: 3 LOCATION: Herbert St between University and Essex St. in Hillcrest

PROJECT DESCRIPTION: Special Event Permit for a recuring Sunday community event that would include live music, alcohol, food vendors/food trucks, and entertainment, onsite food preparation, and the temporary use of a stage, tents/canopies, generator, fencing and/or barriers, portable restrooms, tables, chairs, and recycling and trash containers that would occur on Herbert Street between University and Essex Street on April 21, 2024, May 19, 2024, June 16, 2024. Alcohol would be served from 12 PM until 5:45 PM. Noise associated with the event activities and setup/dismantling would occur from 7 AM until 10 PM on three days listed above. Set-up would occur from 7 AM until 12 PM, the event would occur from 12 PM until 6:15 PM, and clean-up/dismantling would occur from 6:15 PM until 10 PM. There would be a stage with entertainment, and sound amplification would occur from 10 AM until 6:15 PM on the event dates listed above. Approximately 555 attendees are anticipated throughout the course of the event.

There would be a road and parking closures associated with this event and would include Herbert Street between University and Essex Street from 7 AM until 10 PM, on the event dates listed above.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
