NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Mission Fed ArtWalk

COMMUNITY PLAN AREA: Uptown

COUNCIL DISTRICT: 3

LOCATION: Ash St, Grape St, India St, Kettner Blvd., State St, W. Fir St, W. Date St, W. Cedar St, and W. Beech Streets in Little Italy

PROJECT DESCRIPTION: Special Event Permit for a 2-day ArtWalk festival showcasing visual and performing artists, food and retail vendors, entertainment, and onsite food preparation that would occur on April 27, 2024, and April 28, 2024, on 16 city blocks in Little Italy ranging from Ash Street to Grape Street on India, and Kettner Blvd. to State St. on the side streets of Beech, Cedar, Date and Fir and the Piazza della Famiglia (550 W. Date St.). The event would consist of the temporary use of three stages, sound amplification, generators, tents, tables, chairs, portable restrooms, trash and recycling containers. Sound amplification from performances would occur from 9 AM until 6 PM. Noise associated with the event activities and set-up/dismantling would occur between 7 AM on April 25, 2024, to 3 PM on April 29, 2024. Set-up would occur over three days and would occur from 7 AM until 10 PM on April 25 and April 26, 2024, and then from 6 AM until 11 AM on April 27, 2024. The two-day event would occur on April 27, 2024, from 11 AM until 6 PM and on April 28, 2024, from 10 AM to 5 PM. Dismantling would occur on April 28, 2024, from 5 PM to 11 PM and on April 29, 2024, from 8 AM to 3 PM.

Road closure dates and times associated with this event are shown on the attached map.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing,

licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked before or on the final date of the appeal.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
