# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - PanCAN PurpleStride

**COMMUNITY PLAN AREA:** Mission Bay Park

**COUNCIL DISTRICT:** 2

**LOCATION:** De Anza Cove and surrounding pathways in Mission Bay Park

**PROJECT DESCRIPTION:** Special Event Permit for a 1-mile and 5K Run/Walk event that would include the temporary use of the run/walk routes, children's activities, vendors, a stage, generators, sound amplification, entertainment, pre-packaged food, inflatables, trash/recycling containers, portable restrooms, tents/canopies, tables, and chairs that would occur at De Anza Cove Park and on the pathways and East Mission Bay Drive around De Anza Cove in Mission Bay Park on April 27, 2024. Sound amplification from performances and announcements would occur from 7:30 AM until 11 AM on April 27, 2024. On April 26, 2024, there would be a sound check from 1 PM until 3 PM. Noise associated with the event activities and set-up/dismantling would occur between 8 AM on April 26, 2024, until 5 PM on April 27, 2024. Set-up would occur from 8 AM until 5 PM on April 26, 2024, and from 5 AM until 7:30 AM on April 27, 2024. The event would occur on April 27, 2024, from 7:30 AM until 11 AM, and dismantling would occur from 11 AM until 5 PM. The festival site will be located just south-east of the volleyball court, between the court and the path next to the east parking lot. The course will start at the festival site and exit onto the road from the east parking lot (the intersection of N Mission Bay and Mission Bay Dr. Participants will head south on Mission Bay Dr, exiting the road at Playa Pacifica Park. Participants will then utilize the Bikeway and head north to the finish line (see attached map).

Parking closures associated with this event would occur from 5 AM until 11 AM on April 27, 2024, and would include both sides of E. Mission Bay Drive from 4130 Mission Bay Drive (It is the intersection of Mission Bay Dr & North Mission Bay Dr) to the Hilton Hotel located at 2314 Mission Bay Drive, and both sides of North Mission Bay Drive between Mission Bay Drive and Clairemont Drive. There would be no public parking at the De Anza Cove Parking lot (2887 N Mission Bay Drive) would occur on April 26, 2024, from 4 AM until 6 PM.

A road closure associated with the event would include N. Mission Bay Drive and East Mission Bay Drive between the SD Mission Bay Resort and DeAnza Cove parking lot on April 27, 2024, from 7 AM to 11 AM.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
