NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Little Italy Mercato at ArtWalk

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: 200 and 300 W Cedar St., 200, 300, and 400 W/ Beech St. (see attached map)

PROJECT DESCRIPTION: Special Event Permit for a farmers' market that would include the temporary use of produce vendors, merchandise and food vendors, entertainment, onsite food preparation, portable restrooms, canopies, generators, trash/recycling containers, tables, and chairs that would occur on April 27, 2024, and located on two blocks on West Cedar Street from State Street to Union Street and three blocks on West Beech Street, from Columbia Street to Front Street, for one day only each year when ArtWalk occupies the usual site on West Date Street. Noise associated with the event activities and set-up/dismantling would occur from 4:30 AM until 4 PM on April 27, 2027. Set-up would occur from 4:30 AM until 7:55 AM, the market would be open from 8 AM until 2 PM, and clean-up/dismantling would occur from 2 PM until 4 PM.

A road closure would be associated with the event and would include West Cedar Street between Front Street and State Street, and West Beech Street between Columbia and Front Street, and a bike closure would include the south side of Beech Street, the east and westbound from Front Street to Columbia Street, from 4:30 AM until 4 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.

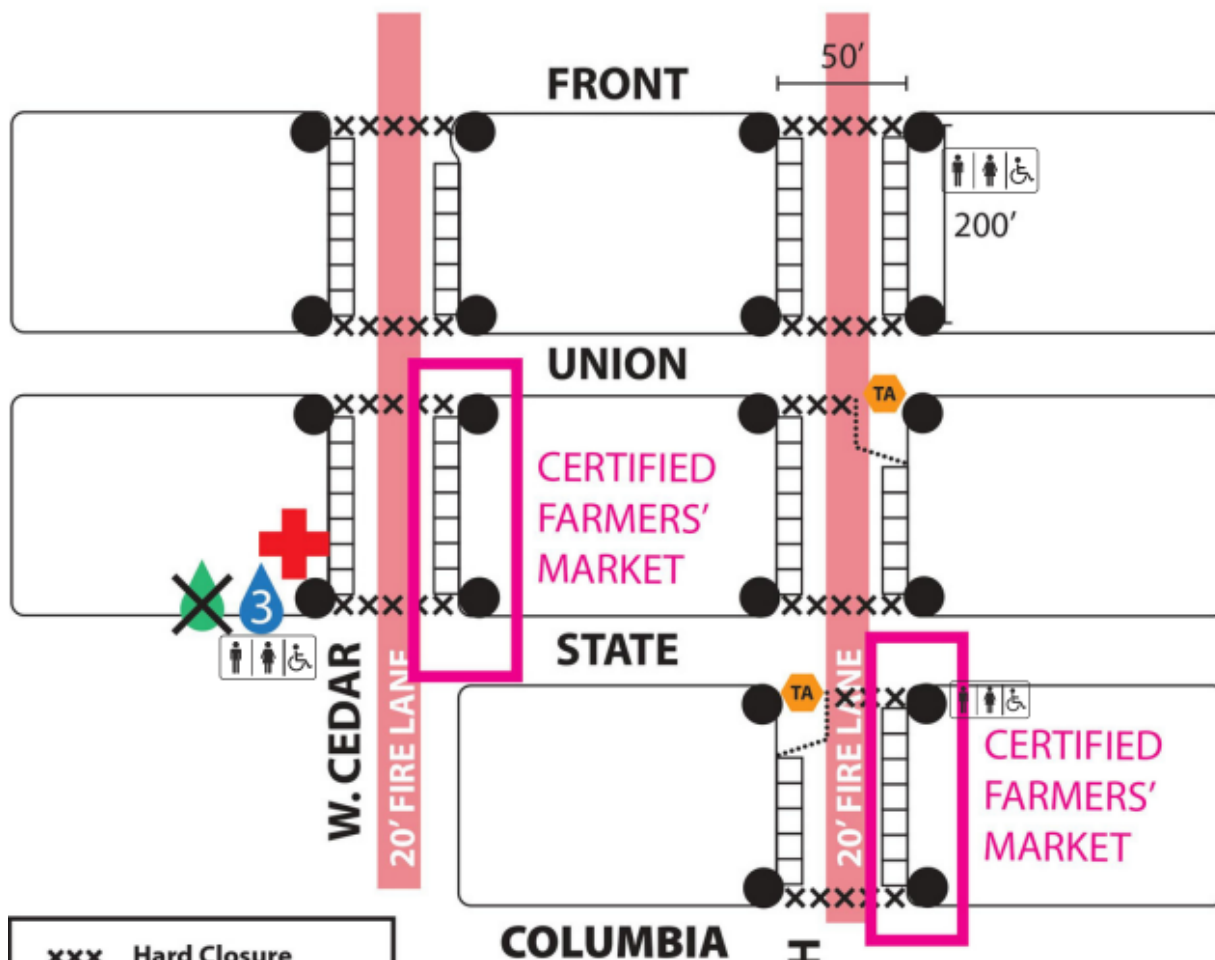
