ITEM-4: **ALVARADO COURT SEWER PIPE CROSSING - PROJECT NO. 168708** City Council District: 7; Plan Area: College Area

Site Development Permit to replace approximately 741 linear feet (LF) of 8-inch diameter sewer mains in the same alignment but at higher invert elevations to improve hydraulics; abandoning approximately 711 LF of 8-inch diameter vitrified clay and cast iron existing sewer mains in place; rehabilitating, abandoning and replacing five (5) sewer manholes. The project also includes the removal of approximately 30 LF of an existing 8-inch cast iron pipe that is exposed in the bed of Alvarado Creek. A small part of these new mains are going to be placed above Alvarado Creek by constructing an overhead crossing structure to avoid impacts to riparian resources.
