Please be advised that the City of San Diego is presently engaged in a recruitment process to fill the position of Executive Director to the Commission on Police Practices (Commission), which is currently held by an interim director. The Commission does not have appointing authority or subject matter jurisdiction over the recruitment or appointment of the Executive Director. Under San Diego City Charter section 41.2, the City Council must appoint and establish the initial annual compensation for the Commission's' Executive Director, who will then serve at the direction and will of the Commission following appointment. To recruit and make advisory recommendations related to the selection of an Executive Director, the City Council has established an Ad Hoc Committee that includes two Councilmembers and four members of the Commission. In-Person Public Comment on an Agenda Item: If you wish to address the Commission on an item on today's agenda, please complete and submit a speaker slip before the Commission hears the agenda item. You will be called at the time the item is heard. Each speaker must file a speaker slip with the Executive Director at the meeting at which the speaker wishes to speak indicating which item they wish to speak on. Speaker slips may not be turned in prior to the day of the meeting or after completion of in-person testimony. In-person public comment will conclude before virtual testimony begins. Each speaker who wishes to address the Commission must state who they are representing if they represent an organization or another person.

For discussion and information items each speaker may speak up to three (3) minutes, subject to the Chair's determination of the time available for meeting management purposes, in addition to any time ceded by other members of the public who are present at the meeting and have submitted a speaker slip ceding their time. These speaker slips should be submitted together at one time to the Executive Director. The Chair may also limit organized group presentations of five or more people to 15 minutes or less.

In-Person Public Comment on Matters Not on the Agenda: You may address the Commission on any matter not listed on today's agenda. Please complete and submit a speaker slip. However, California's open meeting laws do not permit the Commission to discuss or take any action on the matter at today's meeting. At its discretion, the Commission may add the item to a future meeting agenda or refer

the matter to staff or committee. Public comments are limited to three minutes per speaker. At the discretion of the Chair, if a large number of people wish to speak on the same item, comments may be limited to a set period of time per item to appropriately manage the meeting and ensure the Commission has time to consider all the agenda items. A member of the public may only provide one comment per agenda item. In-person public comment on items not on the agenda will conclude before virtual testimony begins.

Virtual Platform Public Comment to a Particular Item or Matters Not on the Agenda: When the Chair introduces the item you would like to comment on (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Chair indicates it is your turn to speak, click the unmute prompt that will appear on your computer, tablet or Smartphone, or dial *6 on your phone. The virtual queue will close when the last virtual speaker finishes speaking or 5 minutes after in-person testimony ends, whichever happens first.

Conflicts and Commission Recusal



Commissioners Have Valuable Expertise

- Many Commissioners are engaged in the community with superior knowledge or SDPD operations and community concerns
- Commissioners were appointed with knowledge of community involvement and after background checks



CONFLICTS OF INTEREST

May Exist when Commissioners become involved in complaints against the SDPD

Conflicts have one thing in common:
 Divided Loyalties

DUE PROCESS



In holding the SDPD accountable to the public, Commission evaluation and review must be commensurate with:

- Impartiality
- Objectivity
- Fairness
- Equal treatment to the Public, Complainants, Officers and Department



Commission Review and Evaluation and Investigative Findings and Discipline

- The CPP reviews and makes investigatory and disciplinary findings that could be the subject of legal appeals and judicial action
- CPP involvement requires objectivity, impartiality, fairness and avoidance of conflicts of interest
- A conflict of interest will exist if extraneous factors influence or dictate a Commissioner's actions resulting in a biased decision



A conflict of interest exists if a legislator has any interest or engages in any business, transaction, professional activity, or incurs any obligation, which is in substantial conflict with the discharge of his or her duties in the public interest



If not managed appropriately and left unresolved, a conflict of interest can lead to problems undermining credibility and objectivity...In conflict situations the private capacity interest of the public official/Commissioner may improperly influence the decision making process



NACOLE Code of Ethics

(Incorporated by San Diego Municipal Code Section 261106 (c)(7))

- 1. Personal Integrity;
- 2. Independent Oversight;
 - Integrity
 - Objective Fairness
 - Impartiality
- 3. Transparency;
- 4. Confidentiality;
- 5. Respectful and Unbiased Treatment;
- 6. Professional Excellence;
- 7. Primary Commitment to Community over Personal Interests.



Determining Conflicts

- Government Code section 1090
- 2. Fair Political Practices Act/City Ethics Code / Form 700
- 3. Common Law Conflicts or appearance of impropriety



- To Balance the community knowledge and expertise of Commissioners with the requirement for impartiality and due process, the Commission adopted a policy to require disclosure and recusal where Commissioners have certain involvement in complaints coming before the Commission
- Requirement is to:
- 1) Disclose the potential conflict
- 2) Recuse
- Recusal requires that the Commissioner have no involvement in the matter and leave the room



Commissioner Recusal May Not Be Sufficient in Certain Instances

Recommendation:

Where Commissioners are extensively involved in complaints such that they become a *de facto* complainant, the entire Commission should be recused and avoid any review or evaluation of the matter
