**HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:**

**In Person for Agenda Items and Non-Agenda Public Comment:** Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

**Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:** When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing **\*9** on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial **\*6** on your phone.

**Please Note:** Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

***Those participating virtually may NOT cede time to others participating in person or virtually.***

#### **HOW TO PROVIDE WRITTEN COMMENTS:**

**For Agenda Items and Non-Agenda Public Comment:** Submit using the [webform](#), indicating the comment type and item number (if relevant). Comments must be submitted the business day prior to the meeting to be distributed to the Hearing Officer and posted online with the meeting materials. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer [website](#) for further instructions.

**Written Materials:** Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Please Note: Documents related to the Hearing Officer meeting agenda items which are distributed to the Hearing Officer prior to the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 1st Floor, San Diego, CA. 92101.

#### **Late-Arriving Materials:**

Coastal Development Permit and Map Waiver to demolish an existing garage, construct a new 3,327 square-foot single dwelling unit with an 800 square foot accessory dwelling unit adding 436 square-feet to an existing 1,556-square-foot dwelling unit, and creating two condominium units. The 0.16-acre site is located at 7443 Eads Avenue in the RM-1-1 (Residential Multiple Unit) Zone, the Coastal Overlay Zone (Non-Appealable Area 2), and the Coastal Height Limitation Overlay Zone within the La Jolla Community Plan. The project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15303 (New Construction or Conversion of Small Structures) on November 21, 2023. There were no appeals of the environmental determination. [Report No. HO-24-005](#).

**ITEM 2: AT&T COMMUNITY CONGREGATIONAL CHURCH – PROJECT NO. 1081156**

**City Council District:** 2  
**Plan Area:** Pacific Beach

Conditional Use Permit and Neighborhood Development Permit to allow the continued use of an existing Wireless Communication Facility (WCF) with modification to remove a faux mono-cypress tree, supporting nine antennas (including two antennas from a light standard), and replace it with a 30-foot tall faux mono-eucalyptus tree supporting 12 antennas, nine Remote Radio Units (RRU) and upgrade equipment at an existing 466-square-foot equipment enclosure. The site is located at the Community Congregational Church, 2088 Beryl Street, in the RM-1-1 Zone within the Pacific Beach Community Plan. The project was determined to be categorically exempt from CEQA pursuant to CEQA State Guidelines, Section 15301 (Existing Facilities) on January 2, 2024, and the opportunity to appeal that determination ended on January 17, 2024. There were no appeals of the environmental determination. [Report No. HO-24-009](#).
