#### OVERVIEW:

This report details the administration of the Living Wage Ordinance during Fiscal Year 2023 under the Compliance Department, as required by San Diego Municipal Code (SDMC) § 22.4235(c). The report summarizes compliance monitoring and enforcement activities, training and outreach efforts, and program updates.

## **DISCUSSION OF ITEM:**

The Living Wage Ordinance (LWO), adopted by the City of San Diego (City) in 2005, requires covered employers to provide specific wage rates and benefits to workers who perform services on applicable service contracts, financial assistance agreements, or facility agreements with the goal of keeping workers and their families out of poverty.<sup>1</sup> The Office of Labor Standards and Enforcement (OLSE) Living Wage Program is responsible for the monitoring and enforcement of LWO requirements on applicable contracts and agreements. During FY 2023, the Living Wage Program completed program administration, annual wage adjustment review, compliance reviews, complaint investigations, and programmatic updates.

#### **Program Administration**

The Living Wage Program performs the following administrative and programmatic functions to monitor and enforce LWO requirements:

- Ensure covered employees receive required compensation for work performed under applicable service contracts and/or agreements.
- Calculate and announce the new adjusted living wage rates.
- Review and process compliance certifications<sup>2</sup> and exemption applications.
- Ensure covered employers comply with reporting and notification requirements.<sup>3</sup>
- Investigate worker complaints and conduct site visits.
- Provide training and outreach to covered employers, City departments, and stakeholders.
- Streamline and update processes to improve program administration.

## Service Contracts Subject to the LWO

During FY 2023, the Living Wage Program monitored a total of 594 active contracts<sup>4</sup> and 225 covered employers subject to the LWO, with a total value of \$611,822,157.85.<sup>5</sup>

### Annual Living Wage Rate Adjustment

The City's living wage rate consists of two parts: an hourly cash wage rate and a health benefits<sup>7</sup> rate. Covered employers may choose to pay employees the living wage either: (1) as a full cash wage or (2) as an hourly cash wage rate plus a health benefits payment. Per the requirements of the LWO, the living wage increases annually based on the change in the Consumer Price Index for All Urban Consumers (CPI-U) for the San Diego-Carlsbad-San Marcos Metropolitan Statistical Area for the preceding twelve-month period.<sup>8</sup> The health benefits rate must be "consistent with the Affordable Care Act and any other applicable federal and state law provisions."<sup>9</sup> The Living Wage Program calculates and announces the new adjusted rates prior to April 1 each year. The adjusted living wage rates take effect the following July 1 and are applicable for the entire fiscal year. Effective July 1, 2022, the total required wage rate increased by 8.28% to \$17.91, inclusive of basic hourly wage rate (\$15.00) and health benefits (\$2.91).<sup>10</sup> This rate increase was atypical and reflective of the increase in inflation. Table 2 below details the living wage rates for the last five fiscal years.

Covered employers are required to comply with all applicable local, State, and federal employment and labor laws<sup>11</sup>, including the City of San Diego's Minimum Wage & Earned Sick Leave Ordinance (MWO)<sup>12</sup> and California minimum wage. Effective January 1, 2023, the City's minimum wage increased to \$16.30 per hour for all work performed within the geographic boundaries of the City, surpassing the hourly cash wage rate required under the LWO.<sup>13</sup> Minimum wage increases are effective per calendar year, while the living wage rates are effective per fiscal year. To address the disparity between the calculation of the living wage cash wage rate and required City and State minimum wage rates, the Living Wage Program notifies all covered employers that covered employees must be paid the highest applicable rate for hours worked.

#### **Applications for Exemption**

The Living Wage Program tracks and monitors exemption requests from covered employers on a contract basis. Under the LWO,<sup>14</sup> contractors may apply for an exemption from the requirements of the LWO if they fall under one of the following categories: (1) a business that operates with 12 or fewer employees, including sub-contractors; (2) a business operating as a sole proprietorship with no employees; (3) a business organized under IRS section 501(c)(3) (non-profits); or (4) a business

with a collective bargaining agreement that specifically states their agreement supersedes the LWO. Contractors do not receive a universal exempt status from the LWO and may be granted exemptions on a per contract basis. Sufficient documentation must be provided to the City before an exemption request is approved by the Living Wage Program. During FY 2023, staff received and reviewed a total of 136 applications for exemption and 129 were approved. Table 3 below summarizes the types of exemptions approved by the Living Wage Program in FY 2023.

## Training & Outreach

A primary function of the Living Wage Program is to ensure covered employers are compliant with the LWO. Program staff are committed to assisting contractors in understanding and meeting their obligations under the LWO through trainings and outreach. By hosting regular contractor trainings and collaborating with other City departments, the Living Wage Program has increased visibility and awareness of the LWO.

During FY 2023, staff conducted 17 outreach events, including:

- Hosting six contractor webinars on LWO and certified payroll requirements
- Presenting twice at Purchasing & Contracting Department's Procurement Academy to City staff involved in the procurement process
- Participation in the City of San Diego's Career Fair at Balboa Park
- Providing LWO information and requirements to financial assistance recipients at Economic Development's CDBG Agreement Execution Virtual Workshop
- Including LWO information along with OLSE's other wage programs at the inaugural San Diego Wage and Labor webinar, in collaboration with the County of San Diego Office of Labor Standards and Enforcement
- Conducting regular meetings, outreach, research, and discussions with other public agencies who have adopted living wage/minimum compensation ordinances.<sup>15</sup>

## **Enforcement: Compliance Reviews and Complaints**

Contracts subject to the LWO are proactively monitored by the Living Wage Program via a webbased compliance portal. Covered employers are contractually required to submit weekly certified payrolls detailing hours worked and wages paid on covered contracts. The Living Wage Program reviews submitted payrolls for compliance with the LWO.

The Living Wage Program is required to periodically conduct compliance reviews of covered employers.<sup>16</sup> Contracts or covered employers may be selected randomly or based on concerns of noncompliance for compliance reviews. Following the initiation of a compliance review, staff

analyzes payroll records and related documentation, including employee timecards, work schedules, itemized wage statements, and health plan statements, to verify payment of applicable living wage rates to covered employees. Staff also reviews and confirms that employers provide compensated leave to covered employees and comply with all noticing and reporting requirements. Employee interviews on City contracts are conducted when necessary.

When deficiencies or wage violations occur, staff work with the covered employer to recover any restitution owed to covered employees and ensure strict compliance is effectuated moving forward. Violations identified that do not fall under the LWO are referred to the appropriate enforcement agency or City department. During FY 2023, compliance reviews and remedies assessed were lower in comparison to previous years due to a vacancy that was filled at the end of FY 2023. The table below details compliance reviews conducted by staff and findings during the reporting period:

In FY 2023, the Living Wage Program received five (5) complaints. All complaints received alleged non-compliance with payment of the living wage rate and/or non-payment of compensated leave. Of the complaints received, three were unsubstantiated with no findings of LWO violations. Two complaints were substantiated, the first complaint found in violation was for non-payment of the living wage rate and the second violation was for non-payment of the living wage rate and non-payment of compensated leave.

In FY 2021, the Living Wage Program was moved from the Equal Opportunity Contracting Program in the Purchasing & Contracting Department to the Office of Labor Standards & Enforcement (OLSE) in the Compliance Department. OLSE consists of the Minimum, Living, and Prevailing Wage programs and is responsible for coordinating Citywide efforts to improve worker safety and labor standards.<sup>18</sup>

Through this consolidation, OLSE programs have been able to cross-train staff, discuss complaints, and strategize enforcement.

In FY 2023, the Living Wage Program received a complaint from an usher working at Pechanga Arena.<sup>19</sup> During the compliance review and audit of payroll records, Program staff recognized that the business was approved for an exemption of the LWO based on its collective bargaining agreement. However, staff identified there were minimum wage violations. The complaint was referred to OLSE's Minimum Wage Program. The Living Wage Program facilitated communications with the covered employer and provided assistance during the audit. As a result, 83 employees received \$8,971.24 in back wages.<sup>20</sup> At the end of FY 2023, a City employee reached out to the Minimum Wage Program regarding a janitorial worker who had concerns about her pay. The Minimum Wage Program referred the complaint to Living Wage Program for a compliance audit; the investigation was completed and a total of \$1,310.82 in back wages were recovered on behalf of two workers.

Proactive enforcement combined with regular outreach and education are key factors in the successful implementation of the LWO. By monitoring certified payroll records and providing compliance information on the LWO to employers, employees, and City staff, the Living Wage Program can reduce the number of violations and facilitate contractor compliance when underpayments are discovered.

#### Living Wage Program Updates & Accomplishments

During FY 2023, the Living Wage Program worked on streamlining administrative processes after receiving feedback from City departments. Program staff collaborated with the City Attorney's Office to develop an annual Certification of Compliance<sup>21</sup> form. The updated annual certification process allows businesses to certify compliance with the LWO for all purchase orders awarded within a fiscal year. This new form allows contractors to complete only one form for the fiscal year instead of having to complete one for each purchase order awarded. Additionally, Program staff developed a self-attestation form for sole proprietors with no employees, allowing them to certify their type of business for the exemption process. In reviewing the Application for Exemption and required backup documentation being requested from sole-proprietors, Program staff considered the type of services sole-proprietors provided to the City and the barriers the additional documentation being requested was creating to acquire certain types of services. The intent of the LWO is not to create additional roadblocks for small businesses providing services to the City, but to ensure all businesses understand their responsibilities under the LWO. These new forms were developed in fiscal year 2023 and rolled out at the beginning of FY 2024 with department trainings and assistance from the Purchasing & Contracting Department.

The Living Wage Program consists of two budgeted positions: a Supervising Management Analyst and a Senior Management Analyst. At the end of FY 2023, the Compliance Department successfully recruited and onboarded the Senior Management Analyst position and the Living Wage Program is now fully staffed.

When the Compliance Department's OLSE was created, it brought together three wage compliance teams supporting the Living, Minimum, and Prevailing Wage programs. These programs were staffed by different classifications with different pay rates despite doing similar labor compliance

work. Additionally, the Management Analyst series used by the Living Wage Program did not accurately reflect the job duties conducted by staff. In FY 2023, the Compliance and Purchasing & Contracting Departments worked with the Personnel Department to create a new Compliance Officer series that better encompasses the work done by staff in all three of OLSE's programs and the Equal Opportunity Contracting Program (EOC). This job classification series was approved by the Civil Service Commission in FY 2023 and will allow OLSE staff to cross-train and support all OLSE programs as needed. Reclassification of staff to the Compliance Officer series will occur in FY 2024.

## Conclusion

The Office of Labor Standards and Enforcement is committed to the enforcement and ongoing improvement of the Living Wage Program to ensure wages earned are put into workers' pockets. Since the adoption of the ordinance in 2005 and effective date beginning of July 1, 2006, the Living Wage Program has recovered a total of \$639,367 in restitution on behalf of covered employees. OLSE will continue to ensure that covered employers are compliant with the LWO Program requirements.
