Until further notice, Hearing Officer meetings will be conducted pursuant to the provisions of California Government Code section 54953(a), as amended by Assembly Bill 2249.

Effective February 10, 2023, the Hearing Officer will be in person and the meeting will be open for inperson testimony. Additionally, we are continuing to provide alternatives to in-person attendance for participating in Hearing Officer meetings.

HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

<u>In Person for Agenda Items and Non-Agenda Public Comment:</u> Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

<u>Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:</u> When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

Those participating virtually may NOT cede time to others participating in person or virtually.

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the webform, indicating the comment type and item number (if relevant). Comments must be the business day prior for it to be distributed to Hearing Officer. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer website for further instructions.

<u>Written Materials:</u> Instead of submitting materials as an attachment to the <u>webform</u>, you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

HOW TO WATCH THE MEETING:

The public may view the meetings on their scheduled time-on the <u>City of San Diego Public Hearings</u> YouTube channel or within 24 to 48 hours of the meeting depending upon technical streaming issues.

GENERAL INFORMATION:

ITEM 1: OTTERSON RESIDENCE - PROJECT NO. 658664

Staff: Mark Lopez City Council District: 1 Plan Area: Pacific Beach

Coastal Development Permit for the demolition of an existing two-story duplex and construction of a 3,793 square-foot, three-story, single-dwelling unit with an attached two-car garage, terraces, balconies, and a 285 square-foot Accessory Dwelling Unit (ADU); and a Variance to allow a 20-foot driveway width where a 12-foot driveway width is required. The 0.11-acre site is located at 4945-4947 Crystal Drive and is in the Residential Medium (RM-1-1) Base Zone, Coastal (Appealable) Overlay Zone, Coastal Height Limit Overlay Zone, Transit Priority Area, Transit Area Overlay Zone, Parking Beach Impact Overlay Zone, within the Pacific Beach Community Plan and Local Coastal Program Land Use. This project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15303 (New Construction or Conversion of Small Structures) of the State CEQA Guidelines. Report No. HO-23-018.

ITEM 2: PAN RESIDENCE - PROJECT NO. 698872

Coastal Development Permit for the demolition of an existing two-story single-family residence and construction of a three-story, 1,469-square-foot single-family residence with exterior decks and attached garage located at 3812 Bayside Lane. The 0.03-acre site is in the Mission Beach Planned District-Residential-Northern (MBPD-R-N) Base Zone, Coastal (Appealable) Overlay Zone, Coastal Height Limit Overlay Zone, Parking Beach Impact Overlay Zone, Transit Area Overlay Zone and the Transit Priority Area within the Mission Beach Precise Plan and Local Coastal Plan. This project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15302 (Replacement or Reconstruction). Report No. HO-23-020.

ITEM 3: VINES - PROJECT NO. 696766

Plan Area: La Jolla

Coastal Development Permit and Site Development Permit for the remodel of an existing two-story 4,042-square-foot single dwelling unit and the construction of a 1,987-square-foot addition. The 0.46-acre site is located at 8457 Prestwick Drive in the La Jolla Shores Planned District-Single Family (LJSPD-SF) Base Zone, Coastal (Non-Appealable), Coastal Height Limitation, Brush Management, High Fire Severity, and the Parking Impact (Campus) Overlay Zones of the La Jolla Community Plan and Local Coastal Program. This project is exempt from CEQA pursuant CEQA Guidelines Section 15301 (Existing Facilities). Report No. HO-23-021.
