The Hearing Officer will be in person and the meeting will be open for in-person testimony. Additionally, we are continuing to provide alternatives to in-person attendance for participating in Hearing Officer meetings.

HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

<u>In Person for Agenda Items and Non-Agenda Public Comment:</u> Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

<u>Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:</u> When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

Those participating virtually may NOT cede time to others participating in person or virtually.

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the <u>webform</u>, indicating the comment type and item number (if relevant). Comments must be submitted the business day prior for it to be distributed to Hearing Officer. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer <u>website</u> for further instructions.

<u>Written Materials:</u> Instead of submitting materials as an attachment to the <u>webform</u>, you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

HOW TO WATCH THE MEETING:

GENERAL INFORMATION:

ITEM 1: ATC 54TH STREET FRONTAGE - PROJECT NO. 694603

Conditional Use Permit for the continued operation of an existing Wireless Communication Facility (WCF) consisting of six (6) antennas and six (6) Remote Radio Units (RRU) concealed inside a 30-foot-tall mono-elm faux tree and upgrading of the associated equipment inside a 100-square-foot enclosure adjacent to the tree on the ground. The site is located at 3060 54th Street in the RS-1-7 Zone of the Mid City Eastern Area Community Plan. This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA section 15302 (replacement or reconstruction). Report No. HO-23-022.
