**PROJECT NAME:** Design Consultant Services for the Point Loma Wastewater Treatment Plant Scum Injection Concentrators Improvements

**PROJECT DESCRIPTION:** The proposed activity would award a design consultant services contract for providing civil engineering design and environmental services, including on-site geotechnical investigation, for the proposed PLWTP scum injection concentrators improvements.

On March 20, 2024, the City of San Diego made the above-referenced environmental determination pursuant to the California Environmental Quality Act (CEQA). Applications to appeal CEQA determinations made by staff to the City Council must be filed in the Office of the City Clerk within ten (10) business days from the date of the posting of this Notice. An application to appeal this CEQA determination must be filed by 5:00 p.m. on April 5, 2024. Appeal procedures are described in Information Bulletin 505 (https://www.sandiego.gov/sites/default/files/dsdib505.pdf). Appeals to the City Clerk must be filed by email or in person as follows:

The appeal filing fee must be United States Postal Service (USPS) postmarked within five (5) business days of the date the appeal is filed.
