Background

- City Council passed Single Use Plastic Reduction Ordinance in December 2022.
- Effective April 1, 2023 – businesses making under \$500,000 annually automatically exempt.
- **Now** effective April 1, 2024 – citywide compliance.



Background (continued)

Polystyrene foam, commonly known as “Styrofoam”

- Is a threat to the environment in San Diego as litter can be ingested by birds, fish, and other organisms.
- Is energy intensive and costly to recycle.
- Is a potential nuisance contaminant in organic waste recycling.



Background (continued)

- Single-use straws and eating utensils are made of plastic and are a threat to the environment.
- Plastic is not biodegradable.
- Single-use plastics are a potential nuisance contaminant in both the recycling and organic waste recycling streams.



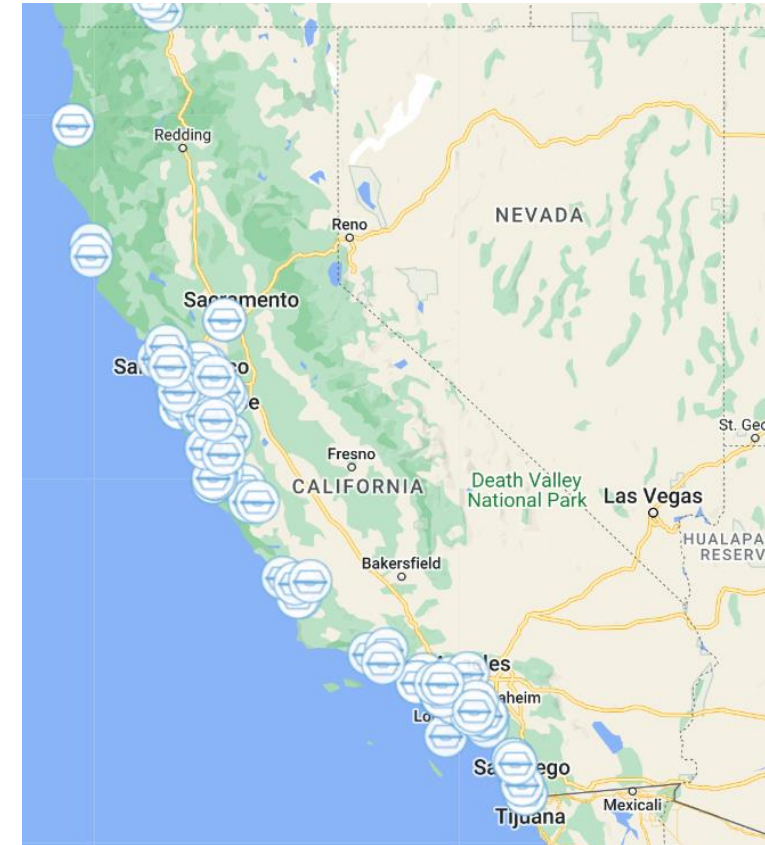
Supports Local Goals

- City of San Diego Climate Action Plan, Strategy 4, Circular Economy and Clean Communities, Measure 4.1, Changes to the Waste Stream calls for the following Action:
 - **Approve and implement the Polystyrene Foam and Single Use Plastics Ordinance**, pending Environmental Impact Report.
- Zero Waste Plan:
 - Reduce landfill disposal by 90% by 2035.
 - Promote local policies and ordinances that encourage manufacturers, consumers, and waste producers to be responsible for waste.



Other California Ordinances

- Over 130 jurisdictions in California have ordinances addressing polystyrene foam including:
 - Alameda County, Long Beach, Los Angeles, Oakland, San Francisco and San Jose.
 - Carlsbad, Del Mar, Encinitas, Imperial Beach, Oceanside, San Marcos, Solana Beach, Vista.



Ordinance

- No person or business may distribute foodservice ware, food trays, or egg cartons made, in whole or in part, from polystyrene foam.
- No person or business may distribute the following if made in whole or part from polystyrene foam unless wholly encapsulated within another material:
 - Coolers, ice chests or similar containers.
 - Pool or beach toys.
 - Dock floats, mooring buoys, anchor or navigation markers.
- No person shall use polystyrene foam products at City facilities (including parks and beaches).



Ordinance (continued)

- A food vendor may only offer plastic and bio-plastic straws and utensils **upon request**.
- Ordinance does not prohibit businesses from providing a self-service station for customers.
- The ordinance does not prohibit asking the customer if they would like to be given a straw or utensils.



Ordinance Definitions

- *Utensils* - straw, fork, spoon or knife made of plastic derived from petroleum or bio-plastics.
- *Foodservice ware* – containers, bowls, plates, trays, cups, lids and other similar items that are designed for one-time use for prepared food, including takeout food or leftovers.
- *Food tray* – a tray commonly used for packaging food to retail consumer.
- *Prepared food* – food or beverages which are serviced, packaged, cooked, chopped, sliced, mixed, brewed, frozen, squeezed or otherwise prepared... but does not include raw eggs or butchered meats, fish or poultry.

Exception

- *"It shall not be a violation of section 66.0902(a) to distribute **prepared food** packaged in foodservice ware or use food trays made, in whole or in part, from polystyrene foam, if the prepared food is packaged outside the City and is provided to the consumer as originally packaged."*
 - **Prepared food means** food or beverages, which are serviced, packaged, cooked, chopped, sliced, mixed, brewed, frozen, squeezed or otherwise prepared within the City of San Diego for individual consumers.
 - **Prepared food includes** takeout food, but **does not include** raw eggs or raw, butchered meats, fish or poultry.

Alternatives to polystyrene foam

Preferred

Material	Product	Comments
Reusable service ware (ceramic, glass, reusable plastic, etc.).	Reusable plates, bowls and cups.	Wash and reuse.
Paper (coated or uncoated).	Bowls, plates, trays, cups, hinged containers, boxes.	Recyclable if dry and free of food and food residue.
Aluminum.	Trays, lidded containers, wrap.	Recyclable if free of food.
Plastic (rigid, non-foam).	Bowls, plates, trays, cups, lids, hinged containers.	Recyclable if free of food.

Alternatives to polystyrene foam (continued)

NOT Preferred

Material	Product	Comments
"Compostable" and "biodegradable" plastic, sugarcane, bagasse, bamboo, molded fiber and other similar items.	Bowls, plates, trays, cups, hinged containers, boxes, lids, wrap.	Not Recyclable, must be placed in trash. Not accepted in local recycling or composting programs. Does not help San Diego reach its zero waste goals.

Unsure about your options?

Ask your current supplier about alternatives to polystyrene foam.

Waivers

- In 2024, waivers are available for:
 - **Financial hardship** - for entities with income of less than \$500,000 per year and for which there is no suitable and reasonably affordable alternative product available.
 - **Feasibility-based hardship** - in the case that no reasonably feasible alternative to polystyrene foam exists.



NOTE:

Automatic financial hardship waivers from April 1, 2023 *expire* March 31, 2024

Waivers (continued)

- Waivers must be submitted to and approved by ESD.
- May include conditions including periodic check-ins with ESD to report progress.
- Waivers will be approved on a case-by-case basis.

Per City of San Diego Ordinance O-21588, adopted on December 8, 2022, no person shall distribute food service ware or food trays, made in whole or in part, from polystyrene foam on or after April 1, 2023.

Enforcement

- Education-first approach
 - San Diego is committed to educating businesses about the ordinance and how to comply.
- Enforcement is complaint based. Currently only providing technical assistance.

Outreach and Implementation

- Education first approach - Technical assistance provided to impacted businesses.
- Working with community groups, environmental groups, trade associations and others to inform the public and those entities impacted by the law on how to comply.
- Over 9,000 multilingual (English, Spanish, Tagalog and Vietnamese) mailers sent to businesses and impacted parties.
- Continued social media outreach – Facebook, Instagram, X, LinkedIn.
- Hosted one recorded webinar and one in-person workshop in March 2023.
- Dedicated ordinance web page, including email distribution list.
- Multilingual materials available – English, Spanish, Tagalog and Vietnamese.
- Sample signage for businesses: informational poster and table tent.





Outreach and Implementation (continued)

Single Use Plastic Reduction Ordinance Effective April 1, 2023

- Distribution of most polystyrene foam containers is prohibited. This includes food service ware such as bowls, plates, trays, cups, lids and other similar items, as well as egg cartons and meat trays.
- Single-use plastic (and bio-plastic) straws and utensils may only be provided upon the request of the customer.
- Single-use plastic (and bio-plastic) straws and utensils can be offered to customers or provided at self-service stations.
- The following may not be distributed if made from polystyrene foam unless encased within another material: coolers, ice chests, or similar containers, pool or beach toys, dock floats, mooring buoys, or anchor or navigation markers.
- All polystyrene foam products are prohibited from City facilities (including parks and beaches).



NOTE: There is an automatic waiver through March 31, 2024, for entities with gross income less than \$500,000 on their most recent Federal income tax filing.

SAN DIEGO SINGLE USE PLASTICS REDUCTION ORDINANCE

EFFECTIVE APRIL 1, 2023



Food vendors may only distribute plastic (and bio-plastic) straws and utensils upon the request of the customer and/or provide them at self-service stations.



The distribution of most polystyrene foam products is prohibited. This includes food service ware such as: egg cartons, bowls, plates, trays, cups, lids, hinged containers and other similar items designed for one-time use for prepared foods, including containers for eating in, takeout food or leftovers.

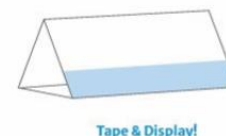
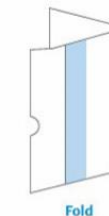
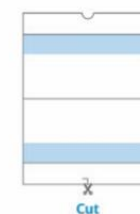


Polystyrene foam, plastic utensils and straws litter the environment, harm wildlife and do not decompose or biodegrade.

Adopted California Laws

- SB 54 - restricts the distribution of polystyrene foam in the state starting on Jan. 1, 2025, if the recycling rate for polystyrene foam in California does not exceed 25% at that time.
- AB 1884 and 1276 - restrict the distribution of straws, single-use utensils and condiment packets by food facilities (complements City's ordinance) unless requested.



Laws regarding reusables

- CA Retail Food Code Section 114075 regarding refilling beverages.
- AB 619 Health and Safety Code amended Sections 114121 and 114353 of the regarding handling of consumer-owned containers.

Why is this important?

Polystyrene foam products are typically used one time before being discarded, and due to their light weight can easily become litter. Polystyrene foam litter breaks down into small pieces which do not biodegrade and often end up in streets, canyons, waterways, storm drains, and eventually the ocean, where it harms wildlife that mistakenly ingests it.

Plastic straws are a significant contributor to marine pollution and are among the most common forms of litter collected on California beaches. They are not accepted in local recycling programs.

The Single Use Plastic Reduction Ordinance will help San Diego reach its [Zero Waste](#) goals and help maintain clean and beautiful beaches and public spaces. The Ordinance will also meet the objectives of the City's Climate
