NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit - Shipwrecks House Music Festival **COMMUNITY PLAN AREA:** Downtown **COUNCIL DISTRICT:** 3 **LOCATION:** 13th Street, 1301 Market St., San Diego, CA 92101

PROJECT DESCRIPTION: Special Event Permit for a music festival, 21 and over, event that would include the temporary use of a stage, entertainment, fencing and/or barriers, onsite food preparation, food vendors, beer garden, alcohol, tents/canopies, a drone, generator, portable restrooms, recycle/trash containers, to occur in Downtown area 13th Street between Market and Island Street on May 4, 2024. Alcohol would be served from 3 PM until 8:30 PM. Noise associated with the event activities and set-up/ dismantling would occur from 6 AM until 11:55 PM on May 4, 2024. There would be stages with entertainment and sound amplification would occur from 1 PM until 9 PM. Set-up would occur from 6 AM until 3 PM, the event would occur from 3 PM until 9 PM, and dismantling would occur from 9 PM until 11:55 PM.

Road/street and parking closures would be associated with the event and would occur from 6 AM until 11:45 PM on May 4, 2024, and would include 13th Street between and Island Avenue.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.


Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 5 business days from the date of the posting of this Notice (**April 17, 2024**). Appeals to the City Clerk must be filed via email or in-person as follows:

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
