# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - Balboa Park Pow Wow

**COMMUNITY PLAN AREA:** Balboa Park

**COUNCIL DISTRICT:** 3

**LOCATION:** SW Corner of Park Boulevard and President's Way in Balboa Park

**PROJECT DESCRIPTION:** Special Event Permit for a two-day culturally based social gathering that would include traditional dancing, music, vendors, food, onsite food preparation, the temporary use of portable restrooms, canopies, tables, chairs, bleachers, trash/recycling containers, and generators that would occur in Balboa Park near President's Way and Park Boulevard on May 11-12, 2024. Approximately 2,000 attendees are anticipated throughout the course of the event. Noise associated with the event activities and set-up/dismantling would occur from 7 AM on May 10, 2024, until 9 AM on May 13, 2024. There would be entertainment, and sound amplification would occur from 9:30 AM until 6 PM on May 11-12, 2024. Set-up for the event would occur over three days from 7 AM until 6 PM on May 10, 2024, from 6 AM until 10 AM on May 11, 2024, and from 7 AM until 10 AM on May 12, 2024. The two-day of the event would occur from 10 AM until 6 PM on May 11, 2024, and May 12, 2024. Dismantling would occur from 6 PM until 10 PM on May 12, 2024, and from 7 AM until 9 AM on May 13, 2024.

Approximately seventy-two (72) parking stalls from the Federal Bldg. parking lot at Park Boulevard and President's Way would be unavailable for public use from 12-midnight on May 10, 2024, until 6 PM on May 12, 2024.

There would be no road closures associated with this event.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for

causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.

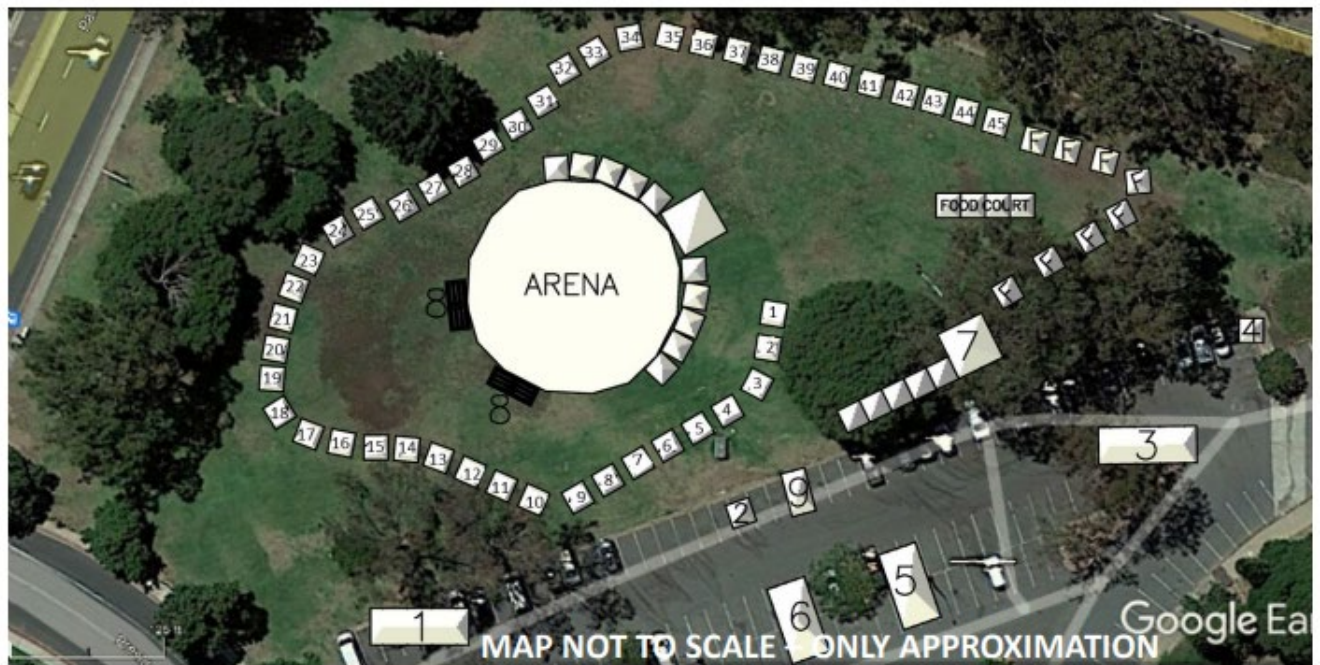
