NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Fiesta de los Penasquitos
COMMUNITY PLAN AREA: Rancho Penasquitos
COUNCIL DISTRICT: 5
LOCATION: Black Mountain Rd., Twin Trails Drive, 13255 Black Mountain Rd

PROJECT DESCRIPTION: Special Event Permit for a community celebration that would occur along Black Mountain Road between Carmel Mountain Road and Twin Trails Drive on May 11, 2024. The event would include a carnival, food vendors, food trucks, onsite food preparation, entertainment, vendors, the temporary use of three stages, tents, generators, fencing and/or barriers, tables, chairs, portable restrooms, and rash/recycling containers. Noise associated with the event activities and setup/dismantling would occur from 8:30 AM on May 10, 2024, until 12 PM on May 13, 2024. Sound amplification from entertainment would occur from 11:30 AM until 6 PM. Setup would occur from 8:30 AM on May 11, 2024, and from 6 AM until 12 PM on May 11, 2024. The event would occur from 12 PM until 6 PM on May 11, 2024. And dismantling would occur from 6 PM until 8 PM on May 11, 2024, and from 8 AM until 12 PM on May 13, 2024.

On May 11, 2024, road and bike lane closures for the event would include Paseo Montalban between Twin Trails Drive and Black Mountain Road from 8 AM until 6 PM, Black Mountain Road between Twin Trails and Carmel Mountain Road.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.



The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.


2. <u>Appeals filed In-Person:</u> The Environmental Determination Appeal Application Form <u>DS-3031</u> can be obtained at:

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
