NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit - 114th Festa of the Holy Spirit (Parade)

COMMUNITY PLAN AREA: Peninsula

LOCATION: 2818 Avenida de Portugal to St Agnes Church at 1140 Evergreen Street

PROJECT DESCRIPTION: Special Event Permit for a parade that would include floats, cars, marching bands, and children and would occur between 2818 Avenida de Portugal to St Agnes Church at 1140 Evergreen Street on May 19. 2024. Noise associated with the event activities and set-up/dismantling would occur from 8 AM until 3 PM on May 19, 2024. Floats/Cars would begin down Canon Street turn left on Shafter Street, turn left on Avenida de Portugal to join the rest of parade up Avenida de Portugal, turn left on Locust Street, turn left on Carleton Street, turn left on Evergreen Street, Stop at Evergreen Street and Avenida de Portugal. Reverse coming back to 2818 Avenida de Portugal. There would be music with the parade and sound amplification would occur from 9:30 AM until 1 PM. On May 19, 2024, set-up for the parade would occur from 8 AM until 10 AM, the parade would occur from 10 AM until 1:30 PM, and the parade would be dismantled from 1:30 PM until 3 PM.

Road closures would be associated with the event and would include: Rosecrans between Canon Street to Emerson Street (8AM-2PM)
Scott Street between Canon Street to Shelter Island Drive (8AM-2PM)
Avenida de Portugal between Scott to Willow Street (8AM-2PM)
Canon between Scott St. to Shafter St. (8AM-10 AM)
Locust Street between Canon Street and Emerson Street (9AM-2PM)
Evergreen Street between Canon Street and Emerson Street (9AM-2PM)
Byron Street between Willow Street and Locust Street (9AM-2PM)
Carlton Street between Willow Street and Locust Street (9AM-2PM)
Shafter Street between Canon Street and Shelter Island Drive (7AM-4PM)
Avenida de Portugal between Scott Street to Shafter Street (7AM-6PM)

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.


