## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - South Bay 5K for Stroke Survivors

**COMMUNITY PLAN AREA:** Otay Mesa - Nestor

**COUNCIL DISTRICT: 8** 

LOCATION: Montgomery-Waller Park - 3020 Coronado Ave, San Diego, CA 92154

**PROJECT DESCRIPTION:** Special Event Permit for a 5K walk event that would occur at Montgomery-Waller Park on May 19, 2024. See site map attached. The event would include fenced in beer garden, alcohol, food vendor, food, onsite food preparation, entertainment, sound amplification, the temporary use of a stage, temporary structures, a generator, fencing and/or barriers, tents, tables, chairs, portable restrooms, and trash/recycling containers. Alcohol would be served from 11 Am until 2:30 PM. Sound amplification from performances would occur from 10:50 AM until 3 PM. Noise associated with the event activities and setup/dismantling would occur from 7 AM until 5 PM on May 19, 2024. Setup would occur from 7 AM until 11 AM, the event would occur from 11 AM until 3 PM, and dismantling would occur from 3 PM until 5 PM. The route would take place within the park. See route map attached.

There would be no road/parking closures associated with the event.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
