## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit - Triton Crit
COMMUNITY PLAN AREA: Mira Mesa

LOCATION: Waples St., Huennekens Street, 9591 Waples St, San Diego, CA 92121

**PROJECT DESCRIPTION:** Special Event Permit for a bicycle criterium race event that would occur along Waples Street and Huennekens Street on May 19, 2024. See site/route map attached. The event would include the route, cyclist, sound amplification, the temporary use of fencing and/or barriers, tents, portable restrooms, and trash/recycling containers. Sound amplification from announcements would occur from 7:45 AM until 3 PM. Noise associated with the event activities and setup/dismantling would occur from 5 AM until 5 PM on May 19, 2024. Setup would occur from 5 AM until 6:30 AM, the event would occur from 8 AM until 3 PM, and dismantling would occur from 3 PM until 5 PM. See route map attached.

There would be road/parking closures associated with the event that would occur on May 19, 2024, from 12 AM until 6 PM, and would include Waples Street between Huennekens Street to Huennekens Street.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
